INDEPENDENT AUDITORS' REPORT

To the Trustees of the
Revelation Pharmacy Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Revelation Pharmacy Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Revelation Pharmacy Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Revelation Pharmacy Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Revelation Pharmacy Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Revelation Pharmacy Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General – The Plan is a defined contribution profit sharing plan generally covering all full-time employees of Everwell Specialty Pharmacy, LLC (the Company) who have completed one year of employment and at least 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 404 (c) of the Internal Revenue Code. The Plan is administered by Everwell Specialty Pharmacy, LLC. However, various record-keeping, compliance, and financial reporting requirements are performed through an independent, contracted plan administrator, ADP Retirement Trust Services.
- b. Contributions – Participants may contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options. The Company matches 100 percent of the first 3 percent of contribution and ½ percent on the next 2 percent of contribution of wages. All contributions are participant directed.
- c. Participant Accounts – Each eligible participant's account is credited with an allocation of (a) the Company's contribution, if any, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Plan investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. At December 31, 2024 and 2023, the vested benefit for terminated employees was \$682,714 and \$442,393, respectively.
- e. Participant Loans – Participants may borrow up to half of the present value of their vested account balance, up to the \$50,000 limits according to the guidelines established by the Plan's Trustees. Loans are payable through payroll deductions over terms ranging up to 5 years. Loans accrue interest at rates determined by the Plan's Trustees which range from 4.50% - 9.50%.
- f. Payment of Benefits - Benefit payments are made in a lump sum payment, in cash, upon the participant's death, disability, or retirement. Normal retirement is at age 65. Prior to termination of employment, participants satisfying certain conditions may be allowed certain in-service distributions subject to certain limitations.
- g. Forfeited Accounts - For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$1,923, respectively. Forfeitures are used to reduce future employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when properly executed requests for distribution are received.

Administrative Expenses

Broker fees are paid from the participants' individual brokerage accounts. The Plan permits the payment of Plan administrative expenses to be made from the Plan assets. These expenses will generally be allocated among the accounts of all participants in the Plan based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued.

There were no material subsequent events which require disclosure at December 31, 2024.

NOTE 3 UNAUDITED INFORMATION

John Hancock Life Insurance Company served as the trustee and custodian of the Plan's investment assets through April 19, 2024, at which point ADP Retirement Trust Services was appointed as the successor trustee. Both trustees held Plan investment assets and executed transactions during the year ended December 31, 2024. Financial information relating to these assets is included in the accompanying financial statements and is based on information provided by the respective trustees. This financial information presented on pages 3, 4, and in Note 6 has not been audited by the independent auditors.

NOTE 4 PLAN AMENDMENTS AND TERMINATIONS

The Plan was restated effective in 2021 as part of the IRS-mandated Cycle 3 restatement process for pre-approved defined contribution plans. This restatement incorporated all required legislative and regulatory changes enacted since the prior restatement cycle, including provisions under the Pension Protection Act (PPA), the Heroes Earnings Assistance and Relief Tax Act (HEART), the Worker, Retiree, and Employer Recovery Act (WRERA), and other applicable IRS guidance.

The Cycle 3 restatement was required by the IRS for all pre-approved plans to maintain their tax-qualified status. The restatement did not result in any changes to the benefits provided under the Plan or participant account balances.

On April 1, 2024, the Plan was restated again in connection with the transition to a new recordkeeper, ADP, and the related change in Plan trustee. This pre-approved plan document incorporated administrative and operational updates to align with ADP's platform requirements. The restatement did not result in any material changes to the benefits provided under the Plan or to participant account balances.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE 5 TAX STATUS

The pre-approved plan document used for the restatement was issued a favorable IRS opinion letter dated October 6, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently operating in compliance with the applicable requirements of the Internal Revenue Code. The federal income tax return of the Plan is subject to examination by the IRS for three years after being filed.

NOTE 6 FAIR VALUE MEASUREMENTS – UNAUDITED

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds – Valued using the net asset values provided by ADP Retirement Trust Services at year end.

Participant Loans – Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 LATE REMITTANCE OF PARTICIPANT CONTRIBUTIONS

During 2022, certain participant contributions and loan repayments were not remitted to the Plan within the required time frame. This issue was identified during subsequent audit and filing delays. The delinquent contributions have since been fully remitted, and as of 2025, the Plan sponsor has completed the calculation and payment of applicable lost earnings to affected participant accounts.
