Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of STEP, Inc. 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of STEP, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. DESCRIPTION OF THE PLAN:

The following description of STEP, Inc. 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lycoming-Clinton Counties Commission for Community Action (STEP), Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants in the Plan may contribute up to a maximum annual amount allowed by the Internal Revenue Code (IRC) of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5.0% of eligible compensation and their contributions invested in a default investment alternative until changed by the participant. The Company contributes a percentage of the participants' elective contribution which is established annually. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers forty-two pooled separate accounts and a guaranteed general account as investment options for participants. Contributions are subject to certain IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with administrative expenses that are paid by the Plan and reduced by distributions to the participants. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Any asset transfers from or to other retirement plans are also credited or charged to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution plus earnings thereon is based on a year of continuous service. A participant is 100% vested after one year of credited service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or designated beneficiary may elect to receive either an amount equal to the value of the participant's vested account in either (a) a lump sum equal to the value of the participant's vested interest in his or her account or (b) approximately equal installments, payable at least annually over the life expectancy of the participant and his or her spouse, if the spouse is a designated beneficiary. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to pay plan expenses or to reduce employer contributions. Forfeited nonvested accounts totaled \$12,880 and \$12,908 as of June 30, 2025 and 2024, respectively. During fiscal year 2025, forfeited nonvested accounts of \$13,105 were used to pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments, including payments to participants and direct rollovers to other retirement plan accounts, are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to custodial and recordkeeping services are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan has a traditional investment contract with Voya Retirement Insurance and Annuity Company (Voya). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the traditional investment contract held by the Plan as of June 30, 2025 and 2024:

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer, but it may not be less than 1.0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include plan termination, contract termination by the plan sponsor, and other withdrawals deemed to be plan sponsor directed as defined by the contract. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract permits the insurance company to terminate the agreement.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There has been no change in the method used at June 30, 2025 and 2024.

Pooled Separate Accounts: Valued at net asset value (NAV) as determined by Voya, the custodian.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the

provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. TAX STATUS:

The Company adopted a volume submitter 403(b) plan which received a favorable opinion letter dated March 31, 2017 from the Internal Revenue Service (IRS) which stated that the prototype was acceptable under section 403(b) of the IRC for use by employers for the benefit of their employees. Although, the Plan has been amended since adopting the pre-approved plan document. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED):

At June 30, 2025 and 2024, the Plan's investments were held by Voya, the custodian of the Plan. The following is a summary of the Plan's financial statements based on information certified by Voya as complete and accurate in accordance with Section 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Voya also certified information included in the supplemental schedule of assets (held at end of year) as of June 30, 2025.

9. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are managed by Voya, custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).

Voya provides custodial and recordkeeping services to the Plan. Fees paid by the Plan for these services amounted to \$73,250 for the year ended June 30, 2025.

Prime Pensions, Inc. provides certain administrative services to the Plan. Fees paid by the Plan for administrative services amounted to \$16,025 for the year ended June 30, 2025.

The Company pays directly any other fees related to the Plan's operations.

10. PLAN AMENDMENT:

Effective July 1, 2024, the Plan was amended to eliminate the provision which excluded the class of temporary employees who normally work less than 20 hours per week for eligibility purposes. The Plan was also amended to comply with the required SECURE 2.0 Act provisions related to discontinuing ROTH required minimum distributions prior to a participant's death and conforming the hardship withdrawal rules to the 401(k) plan rules, as well as the voluntary SECURE 2.0 Act provisions related to increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000.

Effective January 1, 2025, the Plan was amended to comply with the voluntary SECURE 2.0 Act provision related to higher catch-up contribution limits for participants age 60-63.

11. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through January 27, 2026, which is the date the financial statements were available to be issued.

Effective July 1, 2025, the Plan was amended to comply with the required SECURE 2.0 Act provision related to reducing years of service for eligibility of long-term part-time employees from three consecutive years of at least 500 hours to two consecutive years of at least 500 hours.

Effective January 1, 2026, the Plan was amended to comply with the required SECURE 2.0 Act provision related to requiring catch-up contributions for participants with certain compensation limits to be designated ROTH contributions.
