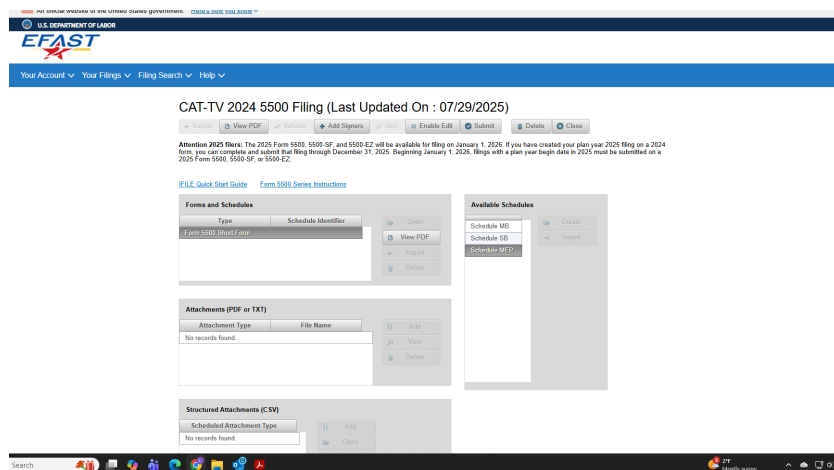

I am in receipt of your email dated, January 27, 2026, stating that our 2024 Form 5500 had not been filed with the DOL. Upon researching the situation, I unfortunately discovered that while I completed the form in advance of the filing deadline, I accidentally failed to complete the final step after signing the forms. The filing has remained in the “Ready to Submit” queue since July 29, 2025.

I must admit this is purely human error and an administrative oversight on my part as the Executive Director of our organization and plan administrator for our retirement plan. I can assure you that I thought we were complying and that I had completed the necessary task. Unfortunately, as is often the case in a small nonprofit organization, I wear many hats and move my focus from one task to the next. Once I completed this task, I simply put the file away and thought that job was done. Clearly, I should have double checked that the filing went through but I moved on to other urgent matters and never thought about it again.

I’ve provided a screen shot of the filing being completed July 29, 2025, here to indicate that my intentions were to file in a timely manner and remain compliant with the necessary requirements.
