DOL,

Our 2024 Form 5500 SF was not filed on time due to some extenuating circumstances. We are a small company, and I am the person responsible for all financial paperwork and filing.


For the 2024 year, there had been a significant error made by our 401K company (Betterment) which resulted in many emails back and forth and our plan documents needing to be amended and adjustments made. This process took a long time, and it was just becoming completed in late July of 2025 which delayed our ability to be prepared. An extension was filed.

Then in early August (August 4th), my mother very suddenly and unexpectedly died which created a need for me to suddenly take on caregiving for my father every week, who lives a 5-hour drive away. This continued from August through December. Due to this, some paperwork tasks on my part got missed, resulting in my missing the filing of our 2024 Form 5500 SF.

I have never missed filing our 5500 in the past 8 years, since 2017 (when we started a 401K plan) and this won't happen again. Normally, I am very on top of paperwork.

Is there any way to be relieved of penalties for our filing late? If you require a copy of my mother's death certificate, I will be happy to supply one.
