### 1. Description of Plan:

The following brief description of the Lyndon Institute, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of Lyndon Institute (the “School”), except for substitute teachers and coaches who are not otherwise teachers or administrators. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 10, 2024, the School transferred all plan assets from TIAA-CREF to Empower Retirement, LLC who now serves as the custodian and recordkeeper for the Plan.

Contributions – Participants may elect to defer pre-tax annual compensation as defined in the Plan. There is no age or prior service requirement for employees to become eligible. Newly eligible participants will be automatically enrolled using a deferral rate of 2% of the participant’s eligible compensation. The Plan also provides participants with the option to contribute deferrals into a Roth 401(k), these deferrals are subject to applicable federal and state income taxes. Participants pre-tax and Roth deferrals are subject to the maximum annual limits as established by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The School contributes a matching contribution equal to 100% of a participant’s elective deferrals up to a maximum of 2% of compensation. The School also contributes employer non-elective contributions to the Plan. For the Plan years ended June 30, 2025 and 2024, the School contributed a contribution equal to 3% of each participant’s contribution to the Plan. Employees eligible to participate in the Vermont State Teacher Retirement Plan are not eligible for the non-elective 3% contribution.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and the School’s corresponding matching and non-elective contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Employee and employer contributions are fully vested and non-forfeitable at the time the contributions are made to the Plan.

Investment Options – Participants may direct their contributions to numerous funds. These funds include a variety of investment options including money market funds, mutual funds, balanced funds, growth and income funds, growth funds, aggressive growth funds and international funds.

Payment of Benefits – Participants may not make withdrawals from their Participant’s Elective Account except for:

- (1) Normal retirement - age 65;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

Distributions will be paid as soon as possible following termination date, except for financial hardship withdrawals which are payable immediately. Distributions are paid to participants in a lump sum, installments, partial distributions, annuities and qualified joint and survivor annuities. To the extent that a participant’s account includes investments in the Empower Retirement, LLC investment option, those distributions must be spread over an 84-month period, except that a lump-sum distribution is available in the 120-day period following termination of employment.

### 1. Description of Plan (continued):

Forfeitures – As participants are at all times 100% vested in their accounts, including the matching contribution, there are no forfeitures in the Plan.

Notes Receivable from Participants – At the discretion of the Plan, participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (i) 50% of a participant's vested account balance as of the date the loan is made or (ii) \$50,000 reduced by the highest outstanding loan balance, if any, from the Plan during the one year period ending immediately before the date of the new loan. Loans are secured by the participant's account and bear a fixed interest rate that will be set at the prevailing rate a loan would be given to the participant in their area. Loan terms are a minimum of 1 year, not to exceed 5 years, except for the purpose of acquiring a primary residence which can be 10 years. Loans are to be repaid through salary reductions consistent with the payroll practices of the School.

### 2. Significant Accounting Policies:

Basis of Accounting – The accounting records of the Plan are maintained on the accrual basis.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Operating Expenses – Custodian fees are paid by the Plan.

Subsequent Events – In preparing these financial statements, management has evaluated subsequent events through January 28, 2026, which represents the date the financial statements were available to be issued.

### 3. **Plan Termination:**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and would be entitled to the full value of their account.

### 4. **Income Tax Status:**

The Plan uses a pre-approved plan document which obtained its latest determination letter on June 30, 2020 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 5. **Information Prepared and Certified by Custodian:**

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Retirement, LLC served as the Plan's custodian. They have provided the Plan administrator with certifications as to the completeness and accuracy of investment balances, participant notes receivable, supplemental schedule, interest, and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations.

### 6. **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant's accounts and the amounts reported in the statements of net assets available for benefits.

### 7. Fair Value Measurements:

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

                      quoted prices for similar assets or liabilities in active markets;

                      quoted prices for identical or similar assets or liabilities in inactive markets;

                      inputs other than quoted prices that are observable for the asset or liability; and

                      inputs that are derived principally from or corroborated by observable market data by correlation or other means.

                      If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

                      Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
