My name is Tuulikki Robertson, and I am the Executive Director of The Black Institute. I am writing regarding our ADP Retirement Plan under Black Institute, Inc., specifically the 401(k) Plan Form 5500/5500-SF filings.

The Form 5500 filings for plan years 2022 and 2024 were not submitted on time due to an administrative issue beyond our immediate awareness. All filing-related notices and communications were sent to a former plan administrator who has not been employed by the organization for the past four years. As a result, I, as the newly designated plan administrator, did not receive any notices, reminders, or correspondence related to these required filings.

We were first made aware of the issue upon receiving a notice from the Department of Labor regarding the 2024 filing. Once notified, we began taking immediate steps to address the matter and ensure compliance moving forward.

Given that the delay was the result of misdirected communications and not willful neglect, we respectfully request a waiver or reduction of any penalties associated with the late filings. We sincerely appreciate your consideration, as The Black Institute acted promptly once we became aware of the issue and remains committed to full compliance.
