INDEPENDENT AUDITORS' REPORT

To the Trustees of

DBSI, INC. 401(k) PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **DBSI, Inc. 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Description of the Plan

The following description of the DBSI, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General - The Plan, established as of November 1, 2011 (the "Effective Date") and restated as of January 1, 2015, is a 401(k) profit sharing defined contribution plan covering all eligible employees of DBSI, Inc. (the "Plan Sponsor") and a related entity under common ownership, Design Drywall West, Inc. (collectively, the "Company"). The Plan is available to all employees of the Company having completed three months of service. Participants enter the Plan on the 1st of the calendar month first following or coinciding with meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In November 2025, the assets of the Plan were transferred from Bankers Trust Company, the former custodian, to Empower as the new custodian of the Plan effective with the transfer.

B. Contributions - Employees of the Company may elect to contribute to the Plan through tax-deferred salary deferrals up to the statutory maximum determined by the Internal Revenue Service ("IRS"). The maximum elective deferral for the year ended December 31, 2024 was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of up to \$7,500 for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan permits participants to make certain tax-free transfer (rollover) contributions of lump sum distributions received from other tax-qualified plans.

Participants are eligible to receive discretionary employer matching contributions as soon as eligible contributions are made by the participant. For the year ended December 31, 2024, the Company authorized a discretionary matching contribution equal to 50% of up to the first 5% of each participant's annual compensation contributed to the Plan. Additionally, the Company may elect to make profit sharing contributions. For the year ended December 31, 2024, the Company did not elect to make a profit sharing contribution.

C. Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, and allocations of Company profit sharing contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting - Participants are immediately vested in deferral and rollover contributions plus any earnings or losses on such contributions. Company profit sharing contributions and matching contributions vest based on years of service as follows:

Participants become 100% vested in their account balance upon reaching normal retirement age, total and permanent disability, death, or Plan termination. Service prior to the Effective Date of the Plan or a predecessor plan is excluded.

- E. Forfeitures** - Forfeitures of non-vested accounts are available to pay Plan administrative expenses, to reduce employer contributions and to be reallocated to participant accounts, in accordance with Plan provisions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$3,070, respectively. During the year ended December 31, 2024, there were \$10,607 of forfeitures used by the Plan to pay Plan administrative expenses.
- F. Notes receivable from participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of his or her vested account balance. A participant may only have one loan outstanding at a time. Loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to the prime rate plus 1% at the time the loan is made.
- G. Payment of benefits** - Distributions are paid in a lump sum and may be made upon termination of employment, attainment of the minimum age requirement for retirement, disability, or death. In service distributions may be made to a participant who has not separated from service provided he or she is a minimum of 59.5 years of age. Participants are allowed to make hardship withdrawals from the Plan in certain situations, as defined in the Plan document.
- H. Administrative expenses** - Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets as administrative expenses. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain plan expenses are paid by the Company. Investment expenses are paid by fees associated with each investment fund.
- I. Termination of the Plan** - Although they have not expressed an intention to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants shall become 100% vested in their account balances.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting - The accompanying financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Payments of benefits - Benefit payments to participants are recorded when paid.

Subsequent events - Plan management has evaluated subsequent events through January 30, 2026, which is the date the financial statements of the Plan were available to be issued.

(3) **Fair value measurement**

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the methodologies used between December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Common/collective trusts: These investments are investment vehicles valued using the NAV provided by the administrator of the funds. The NAV is based on the value of the underlying assets owned by the funds, minus its liabilities, and then divided by the number of shares outstanding. The investments may be redeemed daily with a notice period of one day and had no unfunded commitments as of December 31, 2024 and 2023.

(5) Party-in-interest transactions

Certain investments of the Plan were managed by Bankers Trust Company, as custodian, and therefore these transactions are considered exempt party-in-interest transactions. Fees paid by the Plan to Bankers Trust Company for administrative fees and investment transaction fees totaled \$50,135 for the year ended December 31, 2024.

(6) Tax status

Effective November 1, 2011, the Plan adopted the Dyatech, LLC non-standardized prototype profit sharing plan document (the "Prototype Plan"). The Prototype Plan received an opinion letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Management has not obtained an individual determination letter for the Plan. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(7) Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, credit and market volatility risks. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the statements of net assets available for benefits.

(8) Non-exempt transactions

The DOL's regulations require defined contribution plans to remit participant contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets but not later than the 15th business day of the month following the month in which the participant contributions and loan repayments are withheld by the employer. For the year ended December 31, 2023, the Company failed to remit certain participant contributions and loan repayments to the Plan in a timely manner constituting a lending of such monies to the Company. As such, these transactions represented non-exempt transactions between the Company and the Plan as identified in Schedule H, Line 4(a), Schedule of Delinquent Participant Contributions. The participant contributions and loan repayments during the year ended December 31, 2024 totaling \$6,010 have been remitted to the Plan in 2024, including the lost earnings.

For the year ended December 31, 2024, the Company failed to remit certain participant contributions and loan repayments to the Plan in a timely manner constituting a lending of such monies to the Company. As such, these transactions represented non-exempt transactions between the Company and the Plan as identified in Schedule H, Line 4(a), Schedule of Delinquent Participant Contributions. The participant contributions and loan repayments during the year ended December 31, 2024 totaling \$86 are in the process of correction.
