I am writing to request a waiver of the late filing penalty assessed in connection with Form 5500 for 2024.
EIN# 42-1762033

The Form 5500 was prepared & submitted through Paychex, our authorized third-party administrator, and an extension was properly obtained prior to the original filing deadline. The filing was submitted through the Paychex portal within the extended deadline. At the time of submission, we had no indication that the DOL did not receive the filing.

We were notified for the first time via email dated 1/28/2026 that the DOL had no record of the filing and that it was considered late.
Upon receiving this notice, we immediately took steps to investigate the issue and ensure compliance.

The failure of the filing to be appears to be due to an administrative or transmission issue beyond our control. At all times, we acted in good faith, relied on our third-party service provider.

We have a strong history of timely compliance, and this situation does not reflect willful neglect or disregard of filing obligations. In light of these circumstances, we respectfully request that the late filing penalty be waived please.
