Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Amity Foundation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Amity Foundation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Year Ended June 30, 2024

1. Description of plan:

The following description of the Amity Foundation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in January 1999, and has been amended several times since that date.

General:

The sponsor of the Plan is Amity Foundation (Sponsor). The Plan is a defined contribution retirement plan covering all employees of the Sponsor who have completed 90 consecutive days of continuous service and are at least 21 years of age. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant contributions:

Under the 401(k) provisions of the Plan, participants may elect to defer a portion of their pre-tax annual compensation up to current statutory limits determined annually and prescribed by the Internal Revenue Service. Participants may elect to have all or a portion of their elective deferrals treated as Roth elective deferrals when contributed to the Plan. Roth elective deferrals are includible in the participant's gross income at the time deferred and must be irrevocably designated as Roth elective deferrals. The Plan also permits eligible participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

Employer contributions:

Effective September 1, 2023, the Plan was amended to include a stated match of 100% of the first 3% of participant contributions plus 50% of participant contributions up to the next 2% of eligible compensation. Prior to September 2023, the Plan allowed for discretionary employer matching contributions. Employees needed to complete at least one hour of service during the Plan year in order to receive a discretionary matching contribution. During 2023 and for the period of July 1, 2023 through August 31, 2023, the Board of Directors elected to match 4% of participant deferrals.

The Sponsor may also make discretionary non-elective employer contributions as approved by the Board of Directors. Those contributions are allocated to qualifying participant's accounts with at least 1,000 hours of service during the plan year based on eligible compensation for the year. There were no discretionary non-elective employer contributions made during the 2024 or 2023 Plan years.

Participant accounts:

Each participant's account is credited with the participant's elective deferral, rollover and employer contributions, actual earnings thereon, and charged with an allocation of administrative expenses. The basis for allocations is defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral contributions, and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the employer's contribution portion of the participants' accounts plus actual earnings thereon is based on years of credited service. Participants vest 33% annually beginning with the completion of their first year and are fully vested after three years of credited service. The Plan defines a year of credited service to be a plan year (July 1 through June 30), with at least 1,000 hours of service. Upon the death or total disability of a participant, the participant becomes fully vested in their account balance.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options inside the platform at any time.

Participant loans:

Participants may obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$500. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a longer term. All loans will provide for the repayment of interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator, on the date of the loan. The participant's individual account serves as collateral for the loan. Upon default, death or disability the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statements of net assets available for benefits as notes receivable from participants.

Payment of benefits:

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his/her account, or if the participant is subject to required minimum distributions they may elect installments under a systematic withdrawal plan. Participants with account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. Mandatory distributions under the Plan in excess of \$1,000 are automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions. The Plan also allows participants who have attained the age of 59½ to take in-service distributions from the fully vested portion of their account balance.

1. Description of plan (continued):

Forfeitures:

Forfeitures of terminated participants' nonvested account balances, to the extent attributable to employer contributions, are used to pay for plan administrative expenses or reduce employer contributions.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the vested portion of his/her elective deferral account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies (continued):

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan's management has evaluated the events that have occurred subsequent to June 30, 2024 through December 2, 2025, the date that the financial statements were available to be issued. The Plan's management has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor has adopted a non-standardized pre-approved profit sharing plan with CODA as published by CCH Incorporated dba ftwilliam.com, who obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of the accounts has been estimated using their net asset value as a practical expedient. The net asset value of the funds' shares is determined daily and includes adjustments for investment fees.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Balanced funds: These funds seek to "balance" growth of principal and income by investing in a combination of stocks and bonds.

Bond funds: These funds consist of fixed income securities with the goal of income or growth of income, with less emphasis on capital appreciation.

Global funds: These funds seek to provide greater diversification by investing in stocks of companies within the United States and outside the United States.

Large cap funds: These funds seek growth by investing primarily in stocks of larger companies.

LifeStyle funds: These funds consist of a blend of investments that are re-balanced over time to address retirement goals. Funds with longer horizons are invested more aggressively to achieve growth objectives while shorter-term funds are invested in more conservative securities with the objective of generating income.

Small/mid/specialty funds: These funds seek capital appreciation by investing primarily in stocks of small- and medium-sized companies.

5. Investments:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya), the insurance company of the Plan.

6. Investment contract with insurance company:

The Plan holds a benefit-responsive group combination deferred annuity contract with Voya totaling \$661,204 and \$656,106 at June 30, 2024 and 2023. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

7. Related party and party in interest transactions:

Certain Plan investments are managed by Voya. The Plan paid certain expenses to Voya and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

Non-exempt party in interest transactions:

As disclosed in the accompanying schedule, certain employee deferrals and loan repayments were not remitted to the Plan within the timeframe required by the Department of Labor. Under ERISA, these are considered non-exempt party in interest transactions. The Sponsor will determine the amount of related lost earnings and remit these amounts to participants' accounts subsequent to year end.

8. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
