**Subject: Reasonable Cause Submission for EAST WEST REAL ESTATE GROUP IN 401(K) PROFIT SHARING PLAN & TRUST, EIN: 81-1146312, Plan Number: 001**

To Whom It May Concern:

This letter is submitted to respectfully request a waiver of penalties related to the late filing of Form 5500 for the EAST WEST REAL ESTATE GROUP INC. 401(k) Profit Sharing Plan & Trust (EIN: 81-1146312, Plan Number: 001) for the plan year ending December 31, 2024.

The Form 5500 was not filed by the original due date of July 31, 2025 due to circumstances beyond the control of the plan administrator and was the result of reasonable cause rather than willful neglect.

Specifically, the 401(k) plan, which was administered by Paychex, was in the process of being terminated toward the end of the 2024 plan year. During this transition, we received conflicting guidance from multiple tax professionals regarding whether a Form 5500 filing was required for the 2024 plan year or whether the filing should instead be associated with the plan's termination year.

In an abundance of caution, and with the assistance of Paychex, we proceeded with filing Form 5500 in an effort to ensure compliance and to properly address the 2024 plan year and the plan closure. However, despite the form being marked as a "2024" filing, we later learned that it was processed as a 2025 filing rather than a 2024 filing, resulting in the appearance of a late or missing filing for the 2024 plan year.

**Steps Taken to Resolve the Issue**

Upon discovering this issue on January 30, 2026, we took immediate corrective action. This included gathering all relevant documentation and contacting the Department of Labor using the phone number (866-463-3278) provided in correspondence from Scott Albert, Chief, Division of Reporting Compliance, Office of the Chief Accountant, U.S. Department of Labor, in order to obtain proper guidance and resolve the matter promptly.

Given the plan's termination status, the reliance on professional service providers, the conflicting guidance received, and the immediate actions taken once the issue was identified, we respectfully believe that reasonable cause exists and that a waiver of any associated penalties is warranted.
