I am writing to request the abatement of penalties assessed for the late filing of Form 5500 for the plan year ending 12/31/2024. We acknowledge the delayed filing and the related noncompliance. However, we respectfully request penalty relief based on reasonable cause detailed below.

Explanation of Reasonable Cause:

We respectfully request penalty relief based on reasonable cause. The Form 5500 filing was delayed due to the Administrator's good-faith belief that certain information initially prepared for reporting may have been inaccurate or incomplete. During the preparation process, the Plan Administrator experienced delays in obtaining necessary confirmations and data from the payroll and 401(k) service provider, despite timely and repeated efforts to communicate and resolve the outstanding reporting questions. In order to ensure accurate and complete reporting in compliance with ERISA and Department of Labor requirements and in light of the previous issues we have had with this process, additional time was required to reconcile plan records and verify the information to be reported. Once the required information was received and the reporting concerns were resolved, the Form 5500 was promptly completed and filed. The delay was not due to willful neglect, but rather the result of good-faith efforts to ensure accurate reporting in the best interests of plan participants and beneficiaries.

Request for Penalty Abatement:

In light of these circumstances, we respectfully request DOL waive any penalties due to the reasonable cause described above or reduce them under the Delinquent Filer Voluntary Compliance Program. Our delay was not due to willful neglect but rather an effort to ensure compliance with We are committed to full compliance moving forward.
