My name is Josh Uptegrove, Owner of You First Landscaping LLC.

I created a 401k plan in January of 2020 with my payroll service Paychex.

I tried to cancel this plan in 2021, which was not at all what I thought because I thought it was just for me and not employees, but it was for both.

However, upon cancelling this plan, my payroll service failed to notify the IRS and submit a final 5500 form in October of 2021. Between then and now, I moved addresses and did not receive any notification of a need for a final form until late 2025. I mailed a letter by hand but that was rejected and I am now, as of today February 2nd 2026, sending in a final form I was provided by Paychex indicating this plan was closed 5 years ago. I ask that any penalty be waived and I apologize for any delay in providing updated and accurate information regarding my closed 401k plan.
