### Note 1: Plan Description

The following description of Ariens Company Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all eligible employees of Ariens Company and AriensCo Hospitality LLC (the "Company") who are not leased employees. Employees become immediately eligible to participate in employee deferrals and the Company match after completing three months of service and attaining the age of 18. Effective June 17, 2024, seasonal employees are eligible to participate in employee deferrals and the Company match after completing 1,000 hours of service during a plan year and attaining the age of 21. Under the SECURE 2.0 Act ("Secure 2.0"), effective July 1, 2024 seasonal employees are also eligible to participant upon the completion of three consecutive years of services where the employee completes at least 500 hours of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Retirement Committee is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Contributions

Each year, participants may contribute to the Plan up to 75% of their annual compensation, as defined in the plan document, as pretax or Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan also includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless an alternate election is made. Automatically-enrolled participants have their deferral rate set at 6% of eligible pretax compensation and their contributions invested in a designated fund until changed by the participant. On January 1 of even years, participants with a deferral election of less than 6%, have their deferral election automatically increased to 6% unless a participant made an affirmative elective deferral election during the preceding six months. In addition, at the beginning of each plan year, beginning with the second plan year after the plan year during which the participant became eligible, the deferral election of participants contributing less than 15% to the plan is automatically increased by 2% (up to a maximum deferral of 15%) unless a different election was made. Effective April 30, 2024, and commencing on January 1, 2025, the deferral election of participants contributing less than 15% to the plan will automatically increase by 1% (up to a maximum deferral of 15%) unless a different election is made. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions. From July 1, 2024 to August 31, 2024, the Company made discretionary matching contributions equal to 50% of the first 8% of eligible compensation a participant contributed to the Plan. Effective September 1, 2024, the Company's matching contribution was adjusted to 50% of the first 4% of eligible compensation a participant contributes. Rollover contributions are not matched. In addition to the matching contributions described above, the Company may make additional qualified nonelective contributions ("QNEC") determined at the discretion of the Company.

### **Note 1: Plan Description (Continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contributions, and an allocation of (a) the Company's QNECs and (b) plan earnings or losses. Participant accounts are reduced for withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their salary deferral, rollovers, and Company QNECs, plus actual earnings thereon. Participants become 100% vested in the Company's matching contributions and actual earnings thereon after the completion of three years of service, with no vesting prior to that time.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years unless the note proceeds are used to purchase a primary residence for which the note can exceed five years. The notes are secured by the balance in the participant's account and bear interest at a fixed rate, which approximates market rates at the loan inception date. Interest rates ranged from 4.25% to 9.50% at June 30, 2025. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Plan benefits are available at normal retirement (age 65), disability retirement, death, financial hardship (if certain criteria are met), or termination of employment. Benefits are paid in the form of either a lump-sum amount or partial payment, as requested or required. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's matching contribution. Forfeitures of nonvested account balances are used to reduce future Company contributions or pay administrative expenses at the discretion of the Company.

The Plan had unallocated forfeitures from nonvested accounts of \$186,088 at June 30, 2025, and \$142,269 at June 30, 2024. Forfeitures of \$99,982 were used to pay certain administrative expenses in 2025. Forfeitures of \$727,019 were used to offset Company contributions in 2025.

### **Note 1: Plan Description (Continued)**

#### **SECURE 2.0 Act**

The SECURE 2.0 act, signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain administrative expenses of maintaining the Plan are paid by the Plan. Other administrative expenses are paid by the Company and are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income. Notes receivable from participants and distribution fees are charged directly to the participant's accounts and are included in administrative expenses. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments. All other administrative expenses paid by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

The Plan also participates in a revenue credit program with the trustee, whereby participants may receive credit for excess recordkeeping revenue that the trustee receives in connection with plan services when that revenue exceeds the agreed-upon compensation the trustee is to receive. These revenue credits are allocated to eligible participants based on their respective account balances and are reflected as an offset against administrative expenses.

#### **Subsequent Events**

Subsequent events have been evaluated through January 26, 2026, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

### Note 3: Fair Value Measurements (Continued)

*Common/collective trusts:* Valued at net asset value ("NAV") provided by the plan administrator of the funds using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the funds would sell the underlying investments for an amount different than the reported NAV. The funds are stable value funds and its NAV is based on the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of these investments or unfunded commitments as of June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of June 30, 2025 and 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### **Note 4: Information Prepared and Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

### **Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

### **Note 6: Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Party-in-Interest Transactions**

The Plan holds shares of mutual funds and units of the common/collective trusts managed by Fidelity, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees received by the trustee for administrative services amounted to \$64,445 for the year ended June 30, 2025, as a result of the revenue credit program discussed in Note 2. Certain investment-related fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Associated Trust Company, N.A. ("Associated") is a nondiscretionary trustee of the Plan and acts as an investment advisor. Therefore, the fees paid to Associated qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory services amounted to \$85,000 for the year ended June 30, 2025, which were not covered by revenue sharing.

Strategic Advisors, Inc. ("Strategic") is also a nondiscretionary trustee of the Plan and acts as an investment advisor. Therefore, the fees paid to Strategic qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory services amounted to \$34,255, included in net investment income, for the year ended June 30, 2025, which were not covered by revenue sharing.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

We have audited the financial statements of Ariens Company Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit") for the year ended June 30, 2025, and we have issued our report thereon dated January 26, 2026. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Fidelity Management Trust Company, the Trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America ("GAAS"), as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated September 17, 2025, in addition to our planning discussions with you on September 19, 2025. Professional standards also require that we communicate to you the following information related to our audit.

## Significant Audit Matters

### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2025. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. We had no significant differing opinions regarding management's accounting estimates.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. There were no particularly sensitive disclosures noted for 2025.

The financial statement disclosures are neutral, consistent, and clear.

***Form 5500 Procedures***

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in dealing with management in performing and completing our audit.

***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No such known or likely misstatements were identified during our audit.

In addition, we did not discuss any items that were determined by management to be immaterial, both individually and in the aggregate, to the financial statements taken as a whole.

***Disagreements With Management***

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

***Management Representations***

We have requested certain representations from management that are included in the management representation letter dated January 26, 2026, a copy of which accompanies this letter.

***Management's Consultation With Other Independent Accountants***

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### ***Other Audit Findings or Issues***

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### ***Other Matters***

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Internal Control Matters**

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Plan, an employee benefit plan subject to ERISA, as of and for the year ended June 30, 2025, in accordance with GAAS, we considered the Plan's internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies; therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to error or fraud may occur and not be detected by such controls. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

***Financial Accounting and Reporting***

An entity's internal control over financial reporting does not end at the general ledger but extends to the financial statements and notes. As part of our professional services for the year ended June 30, 2025, Wipfli LLP ("Wipfli") drafted the financial statements and related notes. Because the plan sponsor relies on Wipfli to provide the necessary understanding of current accounting and disclosure principles in the preparation of the financial statements and chose to have Wipfli prepare the financial statements, a significant deficiency exists in the plan sponsor's internal controls.

The completeness of the financial statement disclosures and the accuracy of the overall financial presentation may be negatively impacted, since outside auditors do not have the same comprehensive understanding of the Plan as its internal staff.

***Review of Information Prepared by Third-Party Service Provider***

During our audit, we noted the plan sponsor did not perform timely reviews of certain information prepared or provided by its third-party service provider. The plan sponsor is responsible for the prudent oversight and review of all services provided by third parties to the Plan.

Failure to perform reviews of information prepared or provided by the third-party service provider could result in undetected errors or misstatements in plan financial reporting. We recommend the plan sponsor perform various periodic reviews and reconciliations of information provided by the third-party service provider, including:

- (a) Reconciling total plan assets per the participant detail (the sum of the individual participant account balances) provided by the Plan's recordkeeper to total plan assets reported by the Trustee.
- (b) Reviewing detailed participant account balances maintained by the Plan's recordkeeper and/or the trust statements maintained by the Trustee on a monthly, quarterly, or annual basis for reasonableness and appropriateness, including a review of investment income and management fee allocations for completeness and accuracy.

### **Other Operational, Administrative, and Internal Control Matters**

During our audit, we also became aware of a deficiency in internal control other than a significant deficiency or material weakness that represents an opportunity for strengthening internal controls and operating efficiency:

#### ***Seasonal Employees***

During our audit procedures, we noted one seasonal employee who became eligible to participate in the Plan during the Plan year but was not properly enrolled. The plan sponsor is calculating a correction for the participant for missed employer match and related lost earnings. We note the Company is now tracking seasonal employee hours and age to properly enroll seasonal employees if requirements are met.

During our 2025 audit, we also identified an employee who converted from seasonal to full-time employment and should have been automatically enrolled into the Plan after completing 90 days of service. However, the employee was not automatically enrolled and was instead enrolled at a later date when a deferral election was made by the participant. As a result of this error, the plan sponsor reviewed its records for 2025 to determine if any other employees who converted employment status during the year were impacted by a similar error, noting no additional employees. The plan sponsor is calculating a correction for the participant for missed employer match and related lost earnings.

We will review the status of these comments during our next audit engagement. We have already discussed many of these comments and suggestions with various plan personnel, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study of the matters, or to assist you in implementing the recommendations to the extent our independence is not impaired.

In addition, our disclosures related to fair value measurements are consistent with the objectives outlined in FASB ASC 820.
32. All required amendments to and filings of Plan documents with the appropriate agencies have been made.
33. The Company adopted a non-standardized pre-approved plan document with an Internal Revenue Service ("IRS") notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
34. The Plan (and the trust established under the Plan) is qualified under the appropriate section of the Internal Revenue Code and we intend to continue them as a qualified plan (and trust). The Plan sponsor has operated the Plan (and trust) in a manner that did not jeopardize this tax status. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations. *No excess deferrals or contributions at June 30, 2025 or 2024.*
35. The Plan has complied with the DOL's regulations concerning the timely remittance of participant contributions to trusts containing assets for the Plan.
36. The Plan has complied with the fidelity bonding requirements of ERISA.
37. We have apprised you of all communications, whether written or oral, with regulatory agencies concerning the operation of the Plan.
38. We have obtained appropriate fee disclosures from covered service providers and have concluded the fees are reasonable. The Plan is in compliance with DOL regulations regarding ERISA Section 408(b)(2).
39. To the best of our knowledge, all existing or potential relationships with New Mountain Capital or Wipfli Advisory LLC have been disclosed, if applicable.
