To Whom It May Concern:

We are submitting this statement on behalf of Christie Law Group, PLLC., the plan sponsor and administrator of the Christie Law Group, PLLC 401(k) Profit Sharing Plan and Trust, EIN 20-2335287 Plan Number 001, regarding the late filing of the Form 5500-SF for the 2024 plan year.

The 2024 Form 5500-SF was prepared on a timely basis, consistent with the plan administrator's established procedures for annual reporting. However, due to an inadvertent administrative oversight, the form was not transmitted and filed as intended. The plan sponsor had already completed and successfully filed the 2025 Form 5500-SF following the plan's termination, which contributed to the mistaken belief that all required filings had been completed.

Upon discovering the omission, the plan sponsor took immediate corrective action to prepare and file the missing 2024 Form 5500-SF.

This omission was unintentional and occurred despite the plan sponsor's good-faith efforts to comply with all ERISA reporting requirements. At this point, the plan has been formally terminated, and all assets were properly distributed as you can see on the 2025 Form 5500.

Given the circumstances and the prompt correction terminated, oversight was identified, we respectfully request that the Department of Labor waive any associated penalties for the late filing of the 2024 Form 5500-SF.
