Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

NOTES TO FINANCIAL STATEMENTS

June 30, 2024

NOTE A – DESCRIPTION OF PLAN

The following description of The Arc of Alachua County, Inc. Discretionary Contribution and Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution 401(k) profit sharing plan covering all employees of The Arc of Alachua, Inc. (“Company”) who have attained age eighteen and completed one year of service. A year of service is defined as any plan year in which an employee completes 1,000 hours of service. Once the eligibility requirements have been met, an employee can enter the Plan on either January 1 or July 1 next following or coincident with meeting the eligibility requirements. These eligibility requirements apply to all money types under the Plan. The Plan became effective October 1, 1987, and a revised plan was adopted as of July 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Eligible employees may elect to make contributions to the Plan in the form of salary reductions not to exceed the annual maximum contribution as defined by United States Treasury Regulations. Participants who have attained the age of 50 before the end of the plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The maximum allowable pre-tax voluntary contribution, as determined by the Internal Revenue Service (IRS), was \$23,000 with a maximum "catchup" contribution of \$7,500 for 2024. All contributions are held in trust and invested by the plan's custodian in accordance with the options elected by the participants (i.e. all investments are participant directed).

Each year, the Company may contribute on behalf of all eligible employees, (1) a safe harbor matching contribution, (2) a discretionary matching contribution to the Plan on behalf of each participant who has made eligible salary deferrals to the Plan, and (3) a profit sharing contribution in an amount determined annually by the board of directors.

For the year ended June 30, 2024, the Company approved (1) a safe-harbor matching contribution of 100% of each eligible participant’s elective deferrals, up to 4% of the participant’s compensation, (2) the Company did not approve a discretionary matching contribution, and (3) the Company did not approve a profit sharing contribution. Contributions are subject to certain limitations.

3. Participant’s Accounts

Each participant’s account is credited with the participant’s contribution, the employer safe harbor matching contribution, allocations of Plan earnings (losses) and charged with benefit payments and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. Vesting

Participants are immediately vested in their voluntary contributions, and the employer’s safe harbor matching contributions, and actual earnings thereon. Vesting in the Company’s optional discretionary contribution and the profit sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant begins vesting after one year of service and is 100% vested after five years of credited service.

NOTE A – DESCRIPTION OF PLAN (continued)

5. Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000, reduced by the larger of the highest outstanding loan balance in the last 12 months, or the outstanding loan balance on the day the loan is made. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator, currently prime plus 1%. Spousal consent, if applicable, is required. Participants may only have one loan outstanding at any given time. Principal and interest is paid ratably through weekly payroll deductions.

6. Payment of Benefits

On termination of service for reasons other than death, a participant is entitled to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In some situations, the participant can elect to roll over the distribution into an IRA or other qualified plan. On termination of service due to death, the Plan also allows the option for extended payments to the designated beneficiary.

7. Forfeitures

Each Plan year, forfeitures are first made to reinstate previously forfeited account balances of former participants who have been reinstated in accordance with the terms of the Plan. The remaining forfeitures, if any, are used to reduce the employer matching and discretionary contributions, respectively. For the year ended June 30, 2024, employer contributions were not reduced by forfeitures. The Plan had available \$159 in forfeited non-vested accounts at June 30, 2024 and 2023.

8. Investment Options

The Plan offers participant directed investment programs. The Plan provides that contributions to the Plan will be invested in certain individual programs as directed by each participant. The Plan currently offers three guaranteed interest accounts and fifty-eight mutual funds as investment options for participants.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

4. Investment Valuation and Income Recognition

The Plan follows the fair value measurement requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in an orderly transaction between market participants. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

The Plan has invested in a fully benefit-responsive investment account with an insurance company. Fully benefit-responsive contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

5. Plan Expenses

Expenses incurred by the Plan for audit fees, plan administration fees, and substantially all other operating expenses are paid by the Company. Investment advisory and management fees are paid by the Plan and reduce the participant's account balances by no more than .5% of the participant's account balance based on a sliding scale.

6. Reclassification

Certain prior year information has been reclassified to conform to the current year presentation. The reclassifications had no effect on prior year change in net assets.

7. Subsequent Events

The Plan has evaluated subsequent events through January 30, 2026, the date the financial statements were available to be issued. No subsequent events have been recognized or disclosed.

NOTE C – FAIR VALUE MEASUREMENTS

FASB ASC 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts (PSAs): Valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying assets values are based on quoted prices, the Net Asset Value (NAV) of the PSAs is not publicly traded. The NAV is reported by John Hancock Life Insurance Company as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions at NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments. The investments in PSA's totaling \$1,940,068 and \$1,711,233 as of June 30, 2024 and 2023, respectively, are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient and therefore have not been categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D – UNAUDITED INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, John Hancock Life Insurance Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of June 30 and for the years then ended:

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to permanently discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that are more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has an investment contract with John Hancock Life Insurance Company. John Hancock Life Insurance Company maintains the contributions in guaranteed interest accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the statements of net assets available for benefits at contract value as reported to the Plan by John Hancock Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note B, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by John Hancock Life Insurance Company, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at June 30, 2024 and 2023 was \$82,167 and \$82,657, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with John Hancock Life Insurance Company. Such events include the following: (a) amendments to the plan documents (including a complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) failure of the trust to qualify for exemption from federal income taxes or any required transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE H – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – RELATED PARTY TRANSACTIONS

John Hancock Life Insurance Company is the trustee of the Plan. Plan investments at June 30, 2024 and 2023 included shares of pooled separate accounts and the investment contract with the insurance company, managed by John Hancock Life Insurance Company. Total fees paid by the Plan to the trustee for administration and investment advisory services were \$650, and \$3,370 paid to CBIZ Benefits & Insurance Services, Inc. the third party administrator for the year ended June 30, 2024. Certain Plan investments included shares of pooled separate accounts managed by the trustee and, therefore, those transactions qualify as party-in-interest transactions.
