Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan's sponsor approved to terminate the Plan as of July 16, 2025, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2024 financial statements to the liquidation basis used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

Note 1. Description of the Plan

The following description of iCAD, Inc 401k Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of iCAD, Inc (Company) with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity is the trustee of the Plan. Fidelity Management Trust Company serves as Plan custodian.

Plan Termination

The Company approved to terminate the Plan effective July 16, 2025. The net assets of the Plan were distributed to participants based on priorities established in the Plan and by ERISA prior to the November 11, 2025 period end through lump sum or rollover payments.

Eligibility

All employees of the Company over the age of 21, other than college co-ops or interns with less than 1,000 hours of service, are eligible to participate in the Plan.

The Plan includes an automatic enrollment provision in which the Company automatically, on behalf of those participants meeting the eligibility criteria, defers 5% of the participants' eligible compensation (as defined). Eligible employees are enrolled 30 days after such employee becomes eligible. These deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may elect to contribute up to 90% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,500 in 2025). In addition, participants who are 50 years of age or older as of December 31, 2025, may contribute an additional "catch up" contribution (\$7,500 in 2025). The Plan also allows for participants to defer funds into a Roth 401(k). These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is \$23,500 combined between both the Roth and the pre-tax deferral. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

Employer Contributions

The Company makes a safe harbor matching contribution of 100% of every dollar contributed, not to exceed 3% of the participants' eligible compensation and 50% of every dollar contributed on the next 2% of the participants' eligible compensation.

The Company may make additional discretionary matching contributions on behalf of eligible participants who are not highly compensated employees and discretionary non-elective contributions on behalf of eligible participants who are employed by the Company on the last day of the plan year and have met the minimum service requirement of 1,000 hours. No additional discretionary matching or non-elective contributions were made during the period from January 1, 2025 through November 11, 2025.

Participant Accounts

Each participant's account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants' voluntary contributions, rollover contributions, safe harbor matching contributions and any earnings thereon vest immediately. Vesting in additional discretionary matching and non-elective contributions and any earnings thereon is based on the number of years of continuous service (as defined). Participants are 100% vested after one year of continuous employment. In the event of death, disability, or attainment of age of 59½, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or in installment payments. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59½ or for special "hardship" reasons (as defined). Distributions to participants are recorded when paid.

The plan also allows partial withdrawals from the vested portion of a participant's account upon termination of employment, retirement, death or disability.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 11, 2025 and December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Further, loans will bear interest at a reasonable percentage interest rate to be determined by the plan administrator and are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will be used to pay the Plan's administrative expenses as they occur. Any remaining forfeitures will serve to reduce future Company contributions. The forfeiture balance was reduced to zero during the period ended November 11, 2025. As of December 31, 2024, the net forfeiture balance was \$1,124. No forfeitures were used during the period ended November 11, 2025.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The Company approved to terminate the Plan effective July 16, 2025. As a result, the Plan has changed its basis of accounting for periods starting January 1, 2025, from the accrual basis to the liquidation basis of accounting.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided for in the Plan document.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of November 11, 2025 and December 31, 2024
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period from January 1, 2025 through November 11, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a stable value fund managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations. The Plan paid \$718 of recordkeeping fees to Fidelity during the period ended November 11, 2025. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no changes in the methodologies used at November 11, 2025 and December 31, 2024:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain government obligations, asset-backed securities, nonconvertible bonds, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly manner.

Note 6. Tax Status

The Plan operates under a non-standardized Preapproved Profit Sharing Plan with CODA adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Fidelity. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through January 29, 2026, which is the date the financial statements were available to be issued.
