To Whom It May Concern:

My name is Bruce Harris, I am the Controller of Serenity Home Healthcare, Inc. I began my tenure as Controller on January 5, 2026. Shortly thereafter, it came to my attention that we had not filed the 5500's for the four plan years noted above.

Serenity Home Healthcare, Inc., has grown over the years. During the plan year for December 31, 2020, we did not have in-house accounting or finance functions. We contracted those services to an outside accountant who failed to file Form 5500. That was also the case for the plan year ending December 31, 2022. We hired an in-house Controller during the plan year ending December 31, 2023. That individual was terminated in November of 2025. The termination was due in part to the fact that certain tasks were not performed on a timely basis. The filing of Form 5500's was one of those tasks. During these periods, institutional knowledge related to compliance deadlines was disrupted, resulting in the missed filing.

Once identified, we took immediate corrective action and filed Form 5500 without further delay. New procedures have been established to ensure continuity of compliance responsibilities regardless of personnel changes.

The delay was unintentional and did not impact the operation of the plan or the protection of participant benefits. Serenity Home Healthcare, Inc. respectfully requests waiver of penalties based on reasonable cause.
