Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1. Description of the Plan**

The following description of the Hankins Lumber Co. Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions, which are available from the plan administrator.

***General***

The Plan is a defined contribution plan sponsored by Hankins Lumber Company, Inc. (Company) for the benefit of its employees and employees of related companies who have at least six months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Capital Bank and Trust Company serves as the Plan's trustee and custodian.

***Participant Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of their eligible compensation, subject to certain limitations of the Internal Revenue Code (IRC). Employee rollovers are also permitted. Participants may change their election as of the first day of the plan year and the first day of the seventh month of the plan year. Participant contributions may be suspended at any time. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

***Employer Contributions***

In prior years, the Plan provided for a safe harbor matching contribution. Effective January 1, 2020, the safe harbor feature was discontinued and employer contributions are discretionary. Employer discretionary contributions totaled \$239,813 and \$227,853 during 2024 and 2023, respectively.

***Participant Accounts and Investment Account Options***

Each participant has the option of directing his/her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of the Plan's administrative expenses not paid by the plan sponsor or through forfeiture funds. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Company's contribution portion of their accounts (prior to 2020) plus investment earnings thereon. Beginning in 2020, vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service.

Notwithstanding the preceding description of vesting, the participant or his designated beneficiary is 100% vested in the participant's entire account balance upon retirement at normal retirement age or disability, as defined by the Plan Document, or death of the participant.

***Payment of Benefits***

The Plan provides for benefits that are payable in a single lump sum upon termination of service with the Company or upon retirement or death. Participants are entitled to make a preretirement withdrawal if they have reached the age of 59½ and are 100% vested in their account from which the distribution is to be made. Any distribution will reduce the value of benefits to be received at normal retirement. Participants may make withdrawals from their accounts before the age of 59½ in the event of a hardship, as defined by the Plan Document.

At December 31, 2024 and 2023, the Plan did not have any assets allocated to accounts of terminated or retired participants who had elected to withdraw from the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,696 and \$19,911, respectively. These accounts will be used to reduce future employer contributions reallocated to participants in the same manner as employer contributions or used to pay administrative expenses. During 2024 and 2023, no forfeitures were reallocated to participants or used to reduce employer contributions or administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedules.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets not active; or other inputs observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 or 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

**Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid recordkeeping fees to Capital Bank and Trust Company of approximately \$1,425 and \$1,475 during 2024 and 2023, respectively. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations. The Company provides certain administrative services at no cost to the Plan.

**Note 6. Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a volume submitter prototype profit-sharing/401(k) plan sponsored by The Retirement Advantage Inc. This prototype plan document has been filed with the appropriate agency.. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 9. Subsequent Events**

During 2025, the Company suffered a large fire which forced them to lay off numerous employees, causing a significant reduction in the number of employees. This resulted in a partial plan termination. Plan management is working with the third-party administrator to fully vest the employees and refund any amounts that were previously forfeited by these employees.

During April 2025, the Company match was terminated.

Subsequent events have been evaluated through January 23, 2026, which is the date the financial statements were available to be issued.
