Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Twin City Foods, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 – Description of Plan

The following description of the Twin City Foods, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution retirement plan established April 1, 1957, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers substantially all employees of Twin City Foods, Inc. (the Company) except for hourly union employees covered by a collective bargaining agreement that does not provide for participation in the Plan, union employee who are actively earning benefits as an active participant under the defined benefit pension plan sponsored by the Company, a leased employee, or an individual classified as an independent contractor. Eligible employees of the Company become eligible to enter the Plan and make salary deferral contributions after completion of one hour of service. Eligible employees of the Company become eligible to receive contributions from the Company after they have completed one year of service (defined as 1,000 hours in a 12-month period), although to be eligible for non-safe harbor matching contributions an eligible employee must contribute a minimum of 3% of eligible compensation. The Company is the Plan's Sponsor and serves as Plan Administrator. The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Company has elected to operate the Plan as a safe harbor 401(k) plan, which is a plan design where the Company commits to making certain contributions described in the Plan document. This commitment to make contributions enables the Company to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, which is why it is called a "safe harbor" plan.

Contributions – Each year, participants may contribute up to 100% of annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes safe harbor matching contributions to eligible employees of 125% of each participant's contributions up to 6% of eligible compensation. The Company makes non-safe harbor matching contributions to eligible employees of 100% of each participant's contributions between 3% to 5% of eligible compensation plus 50% of each participant's contributions between 5% to 10% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting – Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Participants vest in employer non-safe harbor contributions and actual earnings thereon on a graduated scale with 20% vesting after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% on completion of six years of service. Participants also become 100% vested if they are employed by the Company upon death or disability or on or after normal retirement age (age 65).

Notes to the Financial Statements

May 31, 2025 and 2024

Note 1 – Description of Plan – (Continued)

Notes receivable from participants – Participants that are employed by the Company may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's vested account and must be repaid within a period of five years. Under the terms of the Plan document, a participant may only have one loan outstanding at any time and loans will bear a commercially reasonable rate of interest determined by the Plan Trustees. Principal and interest is paid ratably through payroll deductions. As of May 31, 2025, interest rates on outstanding notes receivable from participants ranged from 5.25% to 10.50% with various maturities through May 2030.

Payment of benefits – Upon death, disability, retirement, or termination of service for other reasons, a participant may elect to receive the value of the vested interest in his or her account in either a lump-sum distribution or installments. However, when the participant's vested account balance does not exceed \$1,000, a participant may only receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, participants who are still employed by the Company may elect to receive an in-service distributions as follows: (a) if the participant has attained normal retirement age (age 65) they may elect to receive a distribution of all or any portion of their vested account balance, or (b) if the participant has attained age 62 they may elect to receive a distribution from 2% to 5% of their vested account balance annually.

Forfeitures – Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used to pay administrative expenses or reduce Company contributions. As of May 31, 2025 and 2024, there were no forfeited non-vested accounts. During the years ended May 31, 2025 and 2024, forfeitures were primarily used to pay for administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual basis of accounting.

Use of estimates – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan provides for investments in mutual funds, a collective investment fund, and life insurance contracts. The mutual funds are stated at fair value. The collective investment fund is valued at net asset value as a practical expedient to estimate fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The life insurance contracts are stated at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Notes to the Financial Statements

Note 2 – Summary of Significant Accounting Policies – (Continued)

Investment valuation and income recognition – (continued) – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivables from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Benefit payments – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through January 28, 2026, the date the financial statements were available to be issued.

Note 3 – Information Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the custodian of the Plan, has certified to the completeness and accuracy of the following information as of and for the years ended May 31:

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Observable inputs to the valuation methodology that are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable inputs to the valuation methodology other than quoted market prices (unadjusted) for identical assets or liabilities in active markets. Level 2 inputs include quoted prices for similar assets and liabilities in active markets, quoted prices for identical assets and liabilities in markets that are not active and inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable for the asset or liability and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds:

Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective investment fund:

Units held in the collective investment fund are valued, as a practical expedient, using the NAV per unit of the collective investment fund as reported by the managers of the fund. The NAV is based on the fair value of the underlying assets owned by the collective investment fund, minus its liabilities, and then divided by the number of units outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used as of May 31, 2025 and 2024.

To assess the appropriate classification of investments with the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended May 31, 2025 and 2024 there were no transfers in or out of Level 3.

Notes to the Financial Statements

May 31, 2025 and 2024

Note 5 – Party-in-Interest Transactions

Certain Plan investments are in mutual funds managed by an affiliate of Charles Schwab Trust Bank, the custodian as defined by the Plan. Fees paid by the Plan to all parties-in-interest for general plan administration, recordkeeping, investment management, and advisory services totaled \$88,283 and \$93,820 for the years ended May 31, 2025 and 2024, respectively. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 – Tax Status

The Plan received its latest determination letter on September 6, 2016, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
