To Whom It May Concern:

Waga Energy Inc. respectfully submits this letter to explain the circumstances surrounding the late filing of the Form 5500 for our 401(k) Plan for the plan year ending December 31, 2024.

As a small but rapidly growing company, we experienced significant organizational changes and expansion during 2024 and 2025. At that time, responsibilities for plan administration and related filings were shared between our Accounting and Human Resources teams. Unfortunately, due to competing priorities and limited administrative capacity, the task of filing the Form 5500 for the 2024 plan year was inadvertently overlooked.

We recognize the importance of timely compliance with all ERISA filing requirements and regret this oversight. Since identifying the issue, we have taken steps to prevent a recurrence. Specifically:

- We have added additional staff members to both the Accounting and Human Resources departments in 2025 and will be adding further personnel in 2026 to support our continued growth.
- We have clarified and documented compliance-related responsibilities, including assigning a specific individual to track and manage all benefit plan filings and deadlines.
- We have implemented an internal compliance calendar and review process to ensure that all future filings are completed timely.

We respectfully request that the Department accept this explanation as reasonable cause for the late filing. We remain committed to maintaining full compliance with all ERISA and Department of Labor requirements moving forward.
