In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF THE PLAN**

The following description of the High Touch Holdings, Inc. Employees Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description (SPD) for a more complete description of the Plan's provisions, which is available from the Plan Administrator. The Board of Trustees is responsible for oversight of the Plan.

General - High Touch Holdings, Inc. (Company or Sponsor Company) established the Plan effective as of January 1, 1988. The Plan operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, (Code) and is subject to the applicable provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees of the Company are generally eligible to participate in the Plan immediately following or coincident with the later of the date on which the participant completes 500 hours of service within the first six months following an employee's commencement date or attains age 21. Participants not completing 500 hours of service within the first six months following their commencement dates must have at least 1,000 hours of service measured one year from their commencement date to become eligible.

Contributions - The amount of Company contributions, if any, is determined annually by the Company's Board of Directors in the form of cash and/or additional common shares of the Company. Employee contributions are not permitted. The Plan may permit rollover contributions from other qualified plans, subject to approval by the Plan Administrator.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's accounts based on the ratio of the participant's account balance.

Vesting - Participants vest in the Company contributions and earnings thereon at a rate based upon continuous years of service, becoming fully vested upon completing six years of service. Participants terminating due to normal retirement, death or disability will be 100% vested. Forfeitures are allocated among active participants in accordance with an allocation formula. Participants are fully vested in their rollover contributions.

Put Option - Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock of the preceding year. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits - No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to the participant's beneficiary or, if none, his or her legal representatives) or otherwise terminates employment with the Company and its participating subsidiaries. Additionally, the Plan complies with diversification requirements of the tax law by distributing cash to the eligible participants at the participant's election. The Plan allows a participant to take a distribution in the form of cash.

For participants incurring a separation from service with a vested account balance greater than \$50,000, the vested account balance shall be distributed in substantially equal annual installments over a period of five years.

At December 31, 2024 and 2023, Plan assets include \$2,108,151 and \$2,976,753, respectively, allocated to accounts of terminated or retired participants who have not yet been paid.

Voting Rights - Each participant is entitled to direct the Trustee regarding the voting of such securities allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any share for which a participant has not given instructions. Voting rights include any matters which involve the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, or sale of substantially all assets of a trade or business.

Forfeitures - Forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 are as follows:

Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Diversification - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation under the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution, unless eligible

for floor price protection, in which case, shares are distributed. The election to diversify is made subsequent to year-end based upon shares of employer stock in the participant's account at year-end.

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - All investments, including the common shares of the Company are reported at fair value on December 31, 2024 and 2023. Fair value for the common shares is determined by an annual independent appraisal. The Plan's investment committee reviews the Plan's valuation policies utilizing information provided by the Plan's investment advisors. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Administrative Expenses - Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Subsequent Events - These financial statements considered subsequent events through January 12, 2026, the date these financial statements were available to be issued.

**4. FAIR VALUE OF MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The guidance describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Money Market* - This investment is valued using a quoted price in an active market.

*Sponsor Company Common Stock* - Fair value for this investment is the responsibility of the Plan's trustees. The Plan's trustees contract with an independent appraiser to generate fair value estimates on an annual basis. The Plan has engaged an independent trustee who challenges the reasonableness of the assumptions used and reviews the methodology to ensure the estimated fair value complies with accounting principles generally accepted in the United States.

Description - Sponsor Company Common Stock

Fair Value - \$180.00 and \$281.70 per share at December 31, 2024 and 2023, respectively.

Valuation Techniques - This appraisal was based upon the Income Approach and Market Approach valuation techniques and is consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity and market comparables in earnings and revenue.

Unobservable Inputs - Weighted average cost of capital, long-term revenue growth rate, discount for lack of marketability and control premium.

The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity and market comparables in earnings and revenue.

**5. PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in the Plan Sponsor common stock. The investment transactions are considered related party and party-in-interest transactions. The Plan also has a number of service providers. Such providers are parties-in-interest under ERISA. Transactions between these entities and the Plan qualify as party-in-interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Plan Sponsor reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the trust fund will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code (IRC), and the trustee shall liquidate all assets of the Plan and continue to administer the Plan in accordance with its provisions until all obligations have been satisfied.

**7. TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated May 27, 2014, stating that the Plan is qualified under the Internal Revenue Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC.

Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Such risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**9. OPERATIONS AND MANagements PLANS**

In late August 2024, the Plan Sponsor identified certain events that impacted selected software assets, which significantly increased the development costs required for commercialization. These same events have adversely impacted the Plan Sponsor's liquidity and resulted in material impairment charges. The result of these events also impacted the current year valuation of the Company's common stock, resulting in the \$3,601,687 net decrease in the fair value of investments shown on the Statement of Changes in Net Assets Available for Benefits.

The Plan Sponsors' management has evaluated whether conditions and events raise substantial doubt about the Company's ability to continue as a going concern within one year from the date the financial statements are issued. Based on this evaluation, substantial doubt was initially identified due to increased development costs and impairment charges, strained cash flow, and liquidity concerns in the ongoing support of their investments in long-lived software assets and joint venture. The Plan Sponsor's management plans to alleviate or mitigate substantial doubt regarding the adverse impact on its liquidity through actively implementing plans intended to alleviate this substantial doubt, including asset monetization, cost reductions, the pursuit of

additional financing and ongoing negotiations with a joint venture partner to meet software milestones, and the commercialization of new software assets. Achievement of these plans are significant to the valuation of the Plan Sponsor and thus shares in the ESOP. Accordingly, management believes that its plans are probable of being effectively implemented and will mitigate the conditions that initially raised substantial doubt and provide sufficient cash flow to fund the Plan Sponsor's operations for at least twelve months subsequent to the report date.

Additionally on November 17, 2025, the Plan Sponsor funded the employer contribution receivable of \$650,000 as of December 31, 2024 for 2025 plan year distributions, fees and expenses.
