Explanation:

We have timely filed the 5500 for our plan in the past based on notice and preparation by our recordkeeper, Ascensus, and their automated system. The preparation of the form 5500 is part of the services they provide to us for our plan. They draft the 5500 form for us and then send us a notice that the draft form is ready for approval and filing through the E-Fast system. We did not receive any communication from them on the 2024 plan year 5500, and were unaware that the 5500 had not been filed until we received the notice email from Scott Albert of the Department of Labor on 1/28/2026. We immediately contacted Ascensus and our broker on our plan to address the issue. We also checked our computer system for any communication from Ascensus that the 2024 5500 form has been prepared as they have sent in the past. We did not find any notice or communication. The reason for not filing was an administrative error due to the breakdown in communication with the recordkeeper for our plan Ascensus, who we rely on to prepare the form 5500 for our approval and filing. We have addressed those issues with them to ensure this does not happen again including adding internal reminders in our calendar system at our firm, independent of the Ascensus system, to check on the status for the form 5500 preparation. We worked with Ascensus to get the form 5500 for 2024 completed for filing with this explanation for the reason for the late filing. We are promptly filing the late form and paying the fine to address this issue.
