We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### *Emphasis of Matter – Basis of Accounting*

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

#### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

## **Note 1. Description of the Plan**

The following description of the NCI Information Systems, Inc. Health & Welfare Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

### ***General***

The Plan was established January 1, 1994 to provide health and other benefits to eligible employees of NCI Information Systems Inc. (the “Sponsor” or “Employer”) and their covered dependents. Employees are eligible to participate if they are regular full-time or three-quarter-time employees scheduled to work at least 30 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Although the Plan has been in existence since 1994, this is the first year the Plan’s financial statements are being audited. In 2021, the Sponsor established a trust to hold Plan assets and engaged GSA National as the third-party administrator (TPA) to oversee administrative functions. UnitedHealthcare processes claims on behalf of the Plan. The establishment of the trust resulted in the requirement for an annual audit under ERISA. Prior to 2021, the Plan was self-funded and did not maintain separate trust assets.

### ***Benefits***

The Plan provides health benefits (medical, vision, dental), life insurance, short- and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through COBRA.

### ***Insured Benefits***

The Plan fully insures the vision, dental, life insurance benefits (basic, supplemental and dependent), accidental death and disability benefits (basic, supplemental and spousal) and long-term disability benefits. The Plan Sponsor purchases annual insurance contracts for these insured benefits. Premiums for the insured benefits are paid to the insurance company from the general assets of the Plan.

### ***Stop-Loss Coverage***

The Plan maintains excess risk insurance in an effort to limit its exposure for self-insured benefits including individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims.

### ***Self-Insured Benefits***

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan’s VEBA trust or the general assets of the Sponsor. Despite the Plan’s utilization of third-party claim’s processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

### ***Contributions***

In addition to deductibles and copayments, participants may contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The costs of the benefit plan are shared by the Plan Sponsor and participants. The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis. The Sponsor contributes amounts required to satisfy the fringe benefit contribution obligation under the McNamara O'Hara Service Contract Act (SCA).

### ***Participant Accounts***

A separate Premium Reserve Account is maintained for each participant. The account is credited monthly with the employee and employer contributions for the month, less the premiums paid and administrative expenses incurred on behalf of each participant. Any net contribution in excess of the three-month premium is paid directly to the NCI Information Systems, Inc. 401(k) Profit Sharing Plan by the Sponsor on the participant's behalf. Amounts not yet reimbursed to the Sponsor are recorded as excess premium reserve in the accompanying statements of net assets available for benefits.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the modified cash basis of accounting, an accounting practice permitted by the Department of Labor. Consequently, contributions and reimbursements are recognized when received rather than when due and investment income is recorded when received rather than when earned. Accordingly, the accompanying financial statements are not intended to present the financial position and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Cash and Cash Equivalents***

Cash includes non-interest-bearing accounts held at financial institutions. At times, non interest bearing cash may exceed amounts insured by the Federal Deposit Insurance Corporation ("FDIC"). The Plan has not experienced losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

### ***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims (IBNR), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Contributions***

Employer and participant contributions are recognized when received by the Plan. Excess employer contributions that have not been applied to an invoice are recorded as deferred revenue in the accompanying statement of net assets available for benefits.

### ***Payment of Benefits***

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Amounts due to benefit providers that have yet to be paid by the Plan are included in accounts payable in the accompanying statements of net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded in accounts payable in the accompanying statements of net assets available for benefits. The third-party claims processor processes claims of participants, dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. Short-term disability payments are processed through the benefit provider and paid from the general assets of the Plan. These payments are recorded within claims expense in the accompanying statement of changes in net assets available for benefits.

***Stop-Loss***

Premiums for stop-loss insurance are included in ASO fees in the accompanying statement of changes in net assets available for benefits.

***Claims Incurred but Not Reported***

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

***Administrative Expenses***

The Plan's administrative expenses consist primarily of fees paid to third-party claims administrators and other service providers. Administrative expenses are paid by the Plan, as provided by the Plan document.

***Subsequent Events***

The Plan has evaluated subsequent events through January 15, 2026, the date the financial statements were available to be issued.

**Note 3. Exempt Party-in-Interest Transactions**

The Plan does not consider employer contributions to the Plan to be party-in-interest transactions. The Sponsor provides certain accounting and administrative functions to the Plan for which no fees are charged. Additionally, the Sponsor pays certain administrative expenses of the Plan.

As described in Note 1, the Plan has arrangements with various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

**Note 4. Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon such termination, the assets will be used to pay benefits under the terms of the Plan.

## **Note 5. Tax Status**

The provisions of Internal Revenue Code (“IRC”) 419A(g)(1), relative to unrelated business income of the Plan, and IRC 419A(c)(1), relative to qualified asset funding limitations are applicable for the Plan year ended December 31, 2021. The Plan’s resident assets at December 31, 2021 did not exceed the qualified asset funding limitations prescribed and, therefore, no unrelated business income as defined in IRC 512(a)(3) or tax obligation was incurred. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status. Neither the Plan nor the Trust has applied for an Internal Revenue Service (“IRS”) determination letter. However, the Plan has been designed and operated in accordance with IRS regulations. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 6. Risks and Uncertainties**

Plan obligations as of December 31, 2021 for claims incurred but not reported are estimated by the Plan’s administrators based on claims data. The estimate is based upon the monetary value of claims reported during the year, the Plan’s historical experience of lag time between date of eligible service and the related claim payment.

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these judgements and assumptions in the near term would be material to the financial statements.
