Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about RiverKids Houston Therapy, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the 2021 Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2021 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Other Matter – 2021 Supplemental Schedules Required by ERISA***

The supplemental schedule of Schedule H, line 4i – Schedule of Assets Held for Investment Purposes is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

***Auditor's Report on the 2020 Financial Statements***

We were engaged to audit the 2020 financial statements of RiverKids Houston Therapy, LLC 401(k) Profit Sharing Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by a qualified institution. In our report dated November 22, 2022, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2020 financial statements, and (b) the form and content of the information included in the 2020 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS  
RIVERKIDS HOUSTON THERAPY, LLC 401(K) PROFIT SHARING PLAN

***NOTE A – Description of Plan***

The following description of the RiverKids Houston Therapy, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan and was adopted effective January 1, 2009 to establish a profit sharing plan for the exclusive benefit of the employees of RiverKids Houston Therapy, LLC (the “Company”). Effective February 22, 2019, the plan was amended and restated to operate as a Safe Harbor 401(k) Plan in order to satisfy certain non-discrimination testing requirements. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent related amendments and revisions.

**Eligibility** – All employees, excluding those employees covered by a collective bargaining agreement or who is a non-resident alien, are eligible to become participants in the Plan after having completed a year of eligibility service (1,000 hours of service). Entry dates into the Plan are the first day of the calendar month, coincident with or next following the completion of one year of eligibility service.

**Contributions** – Eligible participants may elect to defer 100% of compensation. These contributions by individual employees were limited to \$19,500 (participants under 50 years of age) and \$26,000 (participants 50 years of age or older) in 2021. This limitation is periodically adjusted to reflect cost-of-living increases.

Safe Harbor matching contributions are made at 100% of a participant’s contribution up to 4% of eligible compensation. Maximum annual additions (which include employer contributions) shall not exceed the lesser of \$50,000 or 100% of the participant’s compensation, or cause the Plan to exceed the maximum amount allowable as a deduction to the employer under provisions of the Internal Revenue Code. The Company may also make additional discretionary matching and profit sharing contributions, in an amount determined solely at the discretion of the managing body of the Company. Such additional discretionary contributions, if any, are allocated pro rata to all eligible participants based upon the proportion of the participant’s compensation to the total compensation of all eligible participants. For the year ended December 31 2021, there were no discretionary matching contributions made.

**Payment of Benefits** – The normal form of benefit payable under this Plan is a lump sum. If the amount payable is greater than \$1,000 but less than \$5,000, the participant’s vested account balance will be directly rolled over into an individual retirement account maintained by an entity selected by the Company. If the amount payable is greater than \$5,000, the participant must give written consent before the distribution can be made.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and a pro rata share of the earnings of each fund in which the participant has invested.

**Participant’s Investment Options** – Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

***NOTE A – Description of Plan – continued***

**Vesting** – Participants are immediately vested in their salary reduction and rollover contributions plus actual earnings thereon. Participants are vested immediately in the Company’s Safe Harbor matching contribution plus actual earnings thereon. Any discretionary Company contributions (additional matching or profit sharing) and related earnings thereon vest as follows:

Three or more years	100%

Forfeitures may be used to fund employer matching contributions for the year ended December 31, 2021. There were no forfeitures during 2021 and no forfeiture balance available for use at December 31, 2021.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with prevailing rates. The interest rate on loans outstanding at December 31, 2021 ranged from 4.25% to 6.50% with maturity dates ranging from 2022 to 2026. Principal and interest is paid ratably through payroll deductions.

**Administration** – The Company, as the Plan Administrator, may, at its discretion, pay the Plan’s administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. All Plan expenses were paid by the Plan for the year ended December 31, 2021.

***NOTE B – Summary of Significant Accounting Policies***

**Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recognized when earned.

**Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Risks and Uncertainties** – The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

***NOTE B – Summary of Significant Accounting Policies – continued***

**Investment Valuation and Income Recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

**Notes Receivable from Participants** – Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

**Recently Issued Accounting Standards** – Recent accounting pronouncements issued by the Financial Accounting Standards Board (FASB) did not or are not believed by the Plan administrator to have a material impact on the Plan’s present or future financial statements.

***NOTE C – Fair Value Measurements***

FASB ASC Codification 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Codification 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE C – Fair Value Measurements – continued**

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at the fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Mutual funds: Valued at the daily closing price as reported by the fund.

The preceding method described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D – Investments**

The investments presented as of December 31, 2021 and 2020 were certified as complete and accurate by PAi Trust Company, Inc. PAi Trust Company, Inc. also certified to the completeness and accuracy (including gains and losses on investments bought and sold, as well as held during the year) of \$656,425 of net investment gain in the fair value of investments and \$706 interest for the year ended December 31, 2021.

***NOTE E – Tax Status***

The Plan has not received a determination letter from the Internal Revenue Service (IRS) stating that the Plan is qualified under section 401(a) of the Internal Revenue Code. However, the Plan has adopted a qualified volume submitter plan that is qualified under section 401(a) of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2021, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***NOTE F – Plan Termination***

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

***NOTE G – Party-In-Interest Transactions***

Certain plan investments are managed by PAi Trust Company, Inc., the current custodian of the Plan for the year ended December 31, 2021. As the custodian and trustee, these transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration and recordkeeping. These expenses and certain accounting and auditing fees relating to the Plan are paid directly by the Company as the Plan Sponsor. If the Plan Sponsor does not elect to pay Plan related expenses from its own assets, the Plan permits the payment of Plan related expenses from Plan assets.

***NOTE H - Subsequent Events***

The Plan did not have any recognized or non-recognized subsequent events occurring after December 31, 2021. Subsequent events have been evaluated through January 28, 2026 the date the financial statements were available to be issued.
