Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

I have performed an audit of the accompanying financial statements of Lakeridge Paving Company LLC 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Lakeridge Paving Company LLC 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Lakeridge Paving Company LLC (the "Company"). The Plan was restated, effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Trustees are responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Company's Board of Directors.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching age 18, and after completing one month of service, except for union employees, nonresident aliens, and residents of Puerto Rico. Employees enter the Plan on scheduled enrollment dates following their completion of the eligibility requirements.

Contributions

Employee deferrals – Participants may elect to contribute up to 100 percent of pretax annual compensation, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also roll over eligible amounts from other qualified plans. Participants aged 50 and over may elect to defer additional amounts ("catch-up" contributions) to the Plan.

Employer discretionary matching – The Company may elect to make discretionary matching contributions to the Plan, at the option of the Company's Board of Directors. All participants share in the allocations regardless of service completed during the Plan year or employment status on the last day of the Plan year. Employer discretionary matching contributions were \$14,952 for the year ended December 31, 2022. The contribution is paid at each pay date.

Participant Accounts

Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and allocations of the Company's discretionary matching contribution, if any, and plan earnings, and charged with an allocation of investment losses, withdrawals, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options at any time.

Vesting

Participants are vested immediately in their deferral contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of continuous service. A participant becomes 100 percent vested after four years of service.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions, and notes generally must be fully repaid within five years unless it is for the purchase of a primary residence in accordance with Plan provisions.

Payment of Benefits

On termination of service due to any reason, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants with vested account balances of less than \$5,000 and more than \$1,000, without the participant's consent, will receive an automatic distribution to an Individual Retirement Account (IRA), while any account less than \$1,000 will be distributed as a lump sum cash distribution.

Hardship withdrawals and in-service distributions are permitted by the Plan. Hardship withdrawals must be approved by the Plan administrator and are available from all money types that are 100 percent vested, including earnings.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$9,232 and \$7,824, respectively. These accounts shall be used to reinstate previously forfeited account balances, or reduce employer contributions, or to pay reasonable administrative expenses under the Plan. In 2022, no forfeitures were used.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions

Contributions from participants and the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through January 22, 2026, the date the financial statements were available to be issued.

Subsequent to December 31, 2022, but prior to the issuance of these financial statements, the Plan transferred its third-party administration services to a different provider. This change became effective December 9, 2024. In addition, the Plan began the process of transferring its custodian and recordkeeping services to a different provider. Management expects this transfer to be completed by January 31, 2026.

NOTE 3 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts:

The fair values of participation units in the pooled separate accounts are based upon the net asset values (NAV) of such accounts which are provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate accounts less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate accounts will sell the investment for an amount different than the reported NAV. There are no unfunded commitments or significant restrictions on redemptions relating to these investments. The accounts allow for daily redemptions and contributions. The Plan has the ability to redeem the investments at the NAV (or its equivalent) in the near term.

NOTE 4 CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2022, and net depreciation in fair value of investments for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by The Voya Retirement Insurance and Annuity Company (the custodian of the Plan), a qualified institution. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

NOTE 5 RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds managed by The Voya Retirement Insurance and Annuity Company (Voya). Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The Company is a party-in-interest to the Plan. However, there were no transactions with the Company other than employer contributions and the payment of certain administrative expenses on behalf of the Plan. The Plan uses third-party service providers for administration and custodian services. These transactions qualify as exempt party-in-interest transactions.

Loans to participants also qualify as exempt party-in-interest transactions.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing / Money Purchase / CODA plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
