## **Independent Auditors' Report**

To the Plan Administrator  
TMC 401(k) Retirement Savings Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of TMC 401(k) Retirement Savings Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the TMC 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### (a) General

The Plan is a defined contribution plan covering substantially all full-time employees of Therapy Management Corporation and its participating affiliates (collectively, the “Sponsor”), who have reached age 21 and completed three months of service, except for union employees. The Retirement Plan Oversight Committee is responsible for oversight of the Plan. The Retirement Plan Oversight Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan adopted the Bluestar Retirement Services, Inc. non-standardized profit sharing plan which was amended and restated effective January 1, 2022.

#### (b) Contributions

Each year, participants may contribute a portion of their annual compensation up to the maximum amount allowed by law as pre-tax contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. During the year ended December 31, 2024, the Sponsor had a discretionary matching contribution of 33.33% of the first 9% deferred for a maximum of 3%.

#### (c) Participant Investment Account Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investment options as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

#### (d) Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Sponsor’s contributions and Plan earnings. Allocations of Plan earnings are based on participant account balances, as defined in the Plan. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances or specific transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Notes to Financial Statements - Continued

#### (1) Description of Plan - Continued

##### (e) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also fully vested upon death and total permanent disability. Vesting in the remainder of their account is based on years of service. Participants are credited with a year of service for any plan year in which 1,000 hours of service are worked.

The following schedule describes the Plan's vesting provision for Sponsor discretionary matching contributions and related earnings thereon:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than two years	None
Two years but less than three years	25%
Three years but less than four years	50%
Four years but less than five years	75%
Five years or more	100%

##### (f) Notes Receivable from Participants

Participants generally may borrow from their accounts a minimum of \$500 and a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years or over a reasonable period of time for the purchase a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans are collateralized by the vested balance in the participant's account and bear interest at the prime rate at the time of the loan, plus two percentage points. Principal and interest are paid ratably through payroll deductions.

##### (g) Payment of Benefits

Upon termination of employment for any reason, a participant may elect to receive either a lump-sum payment, direct rollover or partial payment for some or all of the value of the participant's vested interest in the account. If a participant's vested balance is \$1,000 or less, the participant will receive a lump-sum distribution of their entire vested account balance. In the event of a distribution that is greater than \$1,000 but less than \$5,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution, then the Plan Administrator will pay the distribution in a direct rollover to an Individual Retirement Account designated by the Plan Administrator. In-service distributions are permitted for participants that attain age 59½, or in situations of hardship or disability, subject to certain limitations as defined.

#### (1) Description of Plan - Continued

##### (h) Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$25,000 and \$6,000, respectively. These accounts may be used to reduce future employer contributions. During 2024, employer contributions were reduced by approximately \$50,000 from forfeited nonvested accounts.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### (c) Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Oversight Committee determines the Plan's valuation policies utilizing information provided by the Plan's custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant contributions are withheld from compensation.

##### (e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and plan management deem the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### (2) Summary of Significant Accounting Policies

#### (f) Payment of Benefits

Benefits are recorded when paid.

#### (g) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### (3) Information Prepared and Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Registered investment companies, at fair value
- Interest bearing cash
- Non-interest bearing cash
- Net appreciation in fair value of investments
- Interest and dividends

#### (5) **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### (5) Fair Value Measurements - Continued

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (8) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (9) Tax Status

Effective January 1, 2022, the Plan adopted the pre-approved plan sponsored by Bluestar Retirement Services, Inc. The pre-approved plan provider has received an opinion letter from the IRS as to the pre-approved plan's qualified status effective June 30, 2020. The pre-approved opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (10) Subsequent Events

The Plan has evaluated subsequent events through October 30, 2025 the date the financial statements were available to be issued, and determined no events have occurred which would require adjustment within the financial statements and related disclosures.
