## Independent Auditor's Report

### Opinion

We have audited the financial statements of West Care Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

## **Note 1 - Description of Plan**

The following description of the West Care Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

### **General**

Generally, the Plan provides benefits to salaried employees and to non-union hourly employees after completion of 300 credited hours of service. Prior to September 1, 2024, employees subject to collective bargaining agreements were not eligible for coverage under this Plan. Effective September 1, 2024, employees subject to collective bargaining agreements are eligible for coverage under this Plan if their collective bargaining agreement specifically states such. Salaried employees are eligible immediately upon their first day of employment. For hourly employees, the date of eligibility is the first day of the month following the completion of 300 hours of work.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan covers the employees of the following wholly owned subsidiaries of Barnard Companies, Inc.:

- Barnard Construction Company, Inc.
- Barcon, Inc.
- Barnard Environmental, Inc.
- Barnard Pipeline, Inc.
- Barnard of Nevada, Inc.
- Barnard of Canada, Inc.
- BFBC, LLC

### **Benefits**

The Plan provides medical, dental, vision, prescription, life insurance, accidental death and dismemberment, and long-term disability benefits to eligible employees of Barnard Companies, Inc. and its wholly owned subsidiaries (Sponsor) and their eligible dependents as defined by the Plan document. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

### **Insured Benefits**

The Plan fully insures the life insurance benefits (basic and dependent), accidental death and dismemberment, and long-term disability benefits through insurance contracts. Premiums for the fully insured benefits are paid to the insurance company from the general assets of the Sponsor and included as premiums paid in the statement of changes in net assets available for benefits.

### **Stop Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. This arrangement covers individual claims over \$125,000 per year for most participants. The Plan also has aggregate coverage for all claims.

### **Self-insured Benefits**

The Plan is “self-insured” for medical, dental, vision, and prescription benefits up to individual and aggregate stop loss limits. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to, or on behalf of participants and is then reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

### **Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Plan shall from time to time evaluate the costs of the Plan and determine the amount to be contributed by the Sponsor. All contributions received, and all assets and earnings of the Plan are solely and irrevocable dedicated to the payment of benefits of the kind and type described above. The Sponsor pays the full cost of basic life, accidental death and dismemberment, and long-term disabilities insurance. Also, certain former employees have elected under the Plan to continue paying health insurance premiums under COBRA.

### **Health Savings Accounts**

The Plan is designed to be used with health savings accounts (HSA). This arrangement allows for tax-favored contributions to such accounts, which are used to pay or reimburse qualifying health expenses subject to a specific ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee and the account cannot be used for anything other than reimbursements for qualified expenses.

### **Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscretionary manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan’s participants.

**Note 2 - Significant Accounting Policies****Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits**

Premiums paid by the Sponsor are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor.

**Stop Loss**

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$410,278 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

**Refunds**

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$283,955 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Receivables and Allowance for Credit Losses**

The Plan has tracked historical loss information for its receivables and determined that all receivables are fully collectible and no allowance for credit losses is needed.

Management believes that the historical loss information it has compiled is a reasonable base on which to determine expected credit losses for receivables held at December 31, 2024 and 2023, because the composition of the receivables at those dates is consistent with that used in developing the historical credit expectations (i.e. the similar risk characteristics of its receivables). Additionally, management has determined that the current and reasonable and supportable forecasted economic conditions are consistent with the economic conditions included in the historical information. As a result, the historical loss rates have not been adjusted for differences in current conditions or forecasted changes. Accordingly, the allowance for credit losses at December 31, 2024 and 2023, is \$-0-.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies and procedures utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statement of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Expenses**

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include managed care fees, accounting fees, actuary fees, preferred provider organization and review fees, and medical administration fees. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are directly paid by the Sponsor, such as professional fees, are excluded from these financial statements.

### **Health Savings Accounts**

HSA's are not considered Plan assets, as they belong to the individual participants and are administered and held by a third-party custodian. Therefore, the accounts are not included in the accompanying financial statements, as there is no obligation of the Plan to pay the benefits.

### **Benefit Obligations**

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year-end. Such estimated amounts are included in the accompanying statements of benefit obligations in the amounts currently payable.

The estimated liability for accumulated eligibility credits was calculated by multiplying the total hours in the employees' hour bank at December 31, 2024 and 2023, by the employer contribution rate of \$2.07 per hour and \$2.15 per hour, respectively. Such estimated amounts are included in the accompanying statements of benefit obligations as other benefit obligations.

### **Subsequent Events**

The Sponsor has evaluated subsequent events through February 2, 2026, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

U.S. government bonds – Valued using pricing models maximizing the use of observable inputs for similar securities.

### Note 4 - Tax Status

The trust funding certain benefits of the Plan received an exemption letter from the IRS dated May 20, 1993, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. Once qualified, the Plan and trust are required to operate in conformity with the IRC to maintain its tax qualification. The Plan administration is not aware of any action or event that has occurred that might affect the trust's qualified status.

Although tax-exempt health and welfare benefit plans are not generally subject to taxation, certain activities of the Plan may be taxable. The investment income of a VEBA may be subject to unrelated business income tax (UBIT) to the extent that assets exceed certain account limits. Additionally, unrelated business taxable income (UBTI) of a tax-exempt entity is subject to taxation. The Plan will recognize future accrued interest and penalties related to unrecognized tax benefits in income tax expense if incurred.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 - Income Taxes**

The Plan is subject to federal and state income taxes related to UBTI. The provision for current income taxes was \$436,223 for the year ended December 31, 2024. There were no deferred taxes for the year ended December 31, 2024.

Cash payments for income taxes, net of refunds received, amounted to \$307,424 for the year ended December 31, 2024.

**Note 6 - Party-in-Interest Transactions**

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. The estimated liability for accumulated eligibility credits is a mathematical calculation using current hour and rate data. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 8 - Concentrations of Credit Risk**

The Plan holds assets in various cash and money market deposit accounts which exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had approximately \$913,915 and \$1,922,000, respectively, in excess of FDIC-insured limits.

**Note 9 - Plan Amendment**

Effective September 1, 2024, the Plan was amended to allow employees subject to collective bargaining agreements to be eligible for coverage under this Plan if their collective bargaining agreement specifically states such.
