NOTES TO FINANCIAL STATEMENTS

October 31, 2025 And 2024

1. Description Of The Plan

The following description of Sandberg, Phoenix, & von Gontard P.C. Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

The Plan, which was adopted on November 1, 1982 and restated on November 1, 2021, by Sandberg, Phoenix & von Gontard, P.C. (the Company), is a defined contribution profit sharing plan with a 401(k) provision. The Plan covers substantially all employees of the Company. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Eligible employees may participate in the Plan immediately upon hire. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Unless the participant elects not to participate or elects to participate earlier, the participant will be automatically enrolled 30 days after satisfying the eligibility requirements.

Contributions

Participants may contribute compensation as pre-tax deferral contributions, Roth contributions, or after-tax contributions up to a combined annual maximum of the lesser of 100% of eligible compensation or the Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants are automatically enrolled in the Plan at a default contribution rate of 6% of compensation. Participants who are automatically enrolled in the Plan, but contribute less than 14%, are subject to an automatic escalation provision each year at a rate of 2%, until the deferral rate reaches 14%. Participants may opt out of the automatic escalation at any time.

Notes To Financial Statements (*Continued*)

The Company may make discretionary matching contributions to be determined annually based on a percentage of employee contributions. Company matching contributions amounted to \$1,435,980 and \$1,345,746 for the years ended October 31, 2025 and 2024, respectively. Included in the discretionary matching contributions are additional minimum contributions that are required to be made by the Company to eligible employees according to the Plan document for top-heavy minimum benefits.

In addition, the Company may make a discretionary profit sharing contribution to be determined annually by the Company. Each eligible participant will receive a portion of this discretionary profit sharing contribution based on their eligible compensation. The Company did not make a discretionary profit sharing contribution for the years ended October 31, 2025 or 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All participant contributions and Company matching and profit sharing contributions are invested at the participant's direction in the investment funds offered by the Plan and selected by the participant.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant is only allowed to have two outstanding loans at any given time. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal plus 1%. Loans must be paid within five years, or 30 years if the proceeds of the loan will be used to acquire a principal residence. Principal and interest are paid back ratably through payroll withholdings.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Company matching contributions and profit-sharing contributions are subject to a four-year graded vesting schedule, with 0% after one year, 34% after two years, 68% after three years, and fully vested after four years. Amounts subject to vesting become 100% vested upon death or disability.

Forfeitures

Participants who terminate their employment and are less than 100% vested in their account will forfeit their non-vested portion. At October 31, 2025 and 2024, forfeited non-vested accounts totaled \$183,707 and \$205,133, respectively. These accounts are eligible to be used to reduce future Company contributions. Company contributions were reduced by \$119,920 and \$98,654 for the years ended October 31, 2025 and 2024, respectively, by forfeited non-vested accounts.

Payment Of Benefits

The Plan provides for retirement benefits to begin upon either the normal retirement age of 65 or the participant's early retirement age of 55 and the completion of ten years of service. All distributions from the Plan are made in one lump-sum payment in cash.

In-Service Withdrawals

Participants may withdraw from the Plan that portion of their account resulting from pre-tax deferral and Roth contributions in the event of undue financial hardship or upon reaching age 59 1/2. Upon reaching age 59 1/2, participants can also withdraw from the plan that portion of their account resulting from employer contributions as well.

Administrative Expenses

Except for loan fees associated with notes receivable from participants and investment advisory fees, all significant administrative expenses of maintaining the Plan are paid by the Company.

2. Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Investment Income Recognition

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at October 31, 2025 or 2024.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded as earned. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of October 31, 2025 and 2024, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Vanguard Fiduciary Trust Company (Vanguard), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Vanguard that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of October 31:

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Notes To Financial Statements (*Continued*)

The three levels of the fair value hierarchy under the standards are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical investments in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar investments in active markets;
- Quoted prices for identical or similar investments in inactive markets;
- Inputs other than quoted prices that are observable for the investment;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the investment has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the investment.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Collective Investment Trust

Valued at the NAV of units of a collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status Of Plan

The Plan was amended and restated effective November 1, 2021, through the adoption of a pre-approved plan document sponsored by The Vanguard Group. The Vanguard Group received an opinion letter dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan has been amended since the date of the most recent IRS opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party In Interest Transactions

Plan investments include shares of registered investment companies managed by an affiliate of Vanguard. The Plan also pays Vanguard fees for certain administrative functions. Also, certain participants have outstanding loans as of October 31, 2025 and 2024. These transactions qualify as allowable party in interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
