We have performed audits of the financial statements of the Worley 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description Of The Plan**

The following description of the Worley 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) plan covering substantially all employees of Worley Warehousing, Inc., Kenwood Record Management, Inc. and Worley Transportation Company, Inc. (collectively, the Employer) who have attained age 18 and completed six months of service, other than those employees covered under a collective bargaining agreement, leased employees, non-resident aliens and Puerto Rican residents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may contribute up to 100% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Once eligible, participants are automatically enrolled in the Plan with a pre-tax deferral amount of 2% of eligible compensation unless the participant elects otherwise or an affirmative election not to participate in the Plan is made.

Under the provisions of the Plan, the Employer elected to make safe-harbor matching contributions equal to 100% of the participant's deferral contributions up to 5% of eligible compensation.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and employer safe-harbor matching contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes To Financial Statements *(Continued)*

#### **Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to \$50,000 or 50% of their vested account balance. The number of outstanding loans for any participant at any time is limited to one. The loans are secured by the participant's vested account balance and bear interest at the prime rate, as determined by the plan administrator. Loan terms may not exceed five years. Principal and interest are paid ratably through payroll deductions.

#### **Vesting**

Participants are immediately vested in their rollover, voluntary and safe-harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their account, including employer matching contributions prior to the Plan's safe-harbor election, is based on a rate outlined in the plan agreement for each year of credited service beginning in the second year of service. Participants are fully vested after six years of credited service or upon death, disability or attainment of the normal retirement age of age 65.

#### **Hardship Withdrawals**

Participants may elect to withdraw all or a portion of their elective contribution account balance if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

#### **Payment Of Benefits**

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the value of the participant's account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, participant vested account balances greater than \$1,000 but less than \$7,000 will be made to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification. Participants with a vested balance of \$1,000 or less will receive a lump-sum payment upon termination.

#### **In-Service Withdrawals**

Active participants who reach age 59½ may withdraw all or part of their vested accounts.

#### **Forfeited Accounts**

As of May 31, 2025 and 2024, forfeited accounts totaled \$0 and \$5, respectively. These accounts may be used to reduce employer safe-harbor contributions or pay plan expenses. During the year ended May 31, 2025, employer contributions of \$21,194 and plan expenses of \$3,186 were paid from forfeited accounts.

### **2. Summary Of Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use Of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of May 31, 2025. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

#### **Contributions**

Contributions from plan participants and the associated contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment Of Benefits**

Benefit payments to participants are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Reclassifications**

Certain 2024 amounts have been reclassified, where appropriate, to conform to the presentation in the 2025 financial statements. The reclassifications had no effect on the overall financial position or changes in net assets available for benefits.

#### **Subsequent Events**

The Plan has evaluated subsequent events through January 21, 2026, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at May 31, 2025 and 2024 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended May 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV per unit based on either the observable NAV of the underlying investment or the NAV of the underlying pool of securities. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding.

### Notes To Financial Statements (Continued)

*Common/Collective Trusts:* Valued at the NAV of units of the trusts. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

## 5. Investment Contract With Insurance Company

The Plan has a guaranteed investment contract with Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### Notes To Financial Statements (*Continued*)

Principal Life Insurance Company maintains the contributions in a general account. The contract does not have specific underlying assets assigned. The issuer of the contract is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the contract issuer but may not be less than 2.75%. The crediting rate is reviewed on a semi-annual basis for resetting.

Certain events may limit the ability of the Plan to transact at the contract value with the contract issuer. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at the contract value with the issuer or participants, is probable.

### **6. Related-Party And Party-In-Interest Transactions**

Certain plan investments are shares of pooled separate accounts, common/collective trusts and an investment contract under a group annuity contract managed by Principal Life Insurance Company and Principal Global Investors Trust Company, members of Principal Financial Group. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, is also a member of the Principal Financial Group. Therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants given to parties-in-interest totaled \$63,922 and \$87,424 at May 31, 2025 and 2024, respectively.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested.

### **8. Prohibited Transactions**

As required by ERISA Section 2510.3-102, the Employer is required to segregate employee contributions to the Plan from its general assets as soon as practicable. During the prior year ended May 31, 2024, the Plan had contributions totaling \$27,814, all of which represented employee salary deferrals, that were not remitted timely. These contributions are considered prohibited transactions.

The Employer will calculate lost earnings and compensate the Plan for such amounts in 2026.

#### **9. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **10. Risks And Uncertainties**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
