### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NANA Regional Corporation, Inc. Employees' Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statements of changes in net assets available for benefits in liquidation and in accumulated plan benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Termination**

As discussed in Note 2 and 10 to the financial statements, the Board of Directors, by resolution dated November 7, 2023, approved the termination of the Plan and plan of liquidation effective March 31, 2024, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. #### Note 1. Plan Description

The following brief description of NANA Regional Corporation, Inc. Employees' Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

**General:** The Plan provides benefits for regular employees of NANA Regional Corporation, Inc. (the Plan Sponsor) and certain subsidiaries that have adopted the Plan, provided they have at least one year of service and attained age 21, except those members of collective bargaining units governed by agreements, which do not specifically provide for participation in the Plan. A year of benefit service is earned upon the completion of at least 1,000 hours of service in a consecutive 12-month period. The Plan provides monthly retirement income to the eligible participants or to a surviving spouse in the event of a participant's death. All contributions are paid by the Plan Sponsor, as computed in accordance with established actuarial principles.

Effective December 31, 2012, the Plan was amended to freeze benefit service and accrued benefits for all Plan participants and eligibility as of that date. On November 3, 2023, the Board of Directors of the Plan Sponsor passed a resolution to terminate the Plan effective March 31, 2024.

**Pension benefits:** The Plan is a defined benefit plan under terms of which participants are eligible for monthly benefit payments upon reaching normal or early retirement age. Participants are vested after completing five years of service. Normal retirement age is 65 or, if later, five years from Plan entry. Early retirement age is 55 with a minimum of five years of service. In the event a participant remains employed after attainment of the normal retirement date, the participant shall be eligible to retire on the postponed retirement date and not be entitled to receive payments of retirement income until actual retirement. Monthly benefit payments are determined by application of a formula, which considers, as factors, an average of the highest paid three consecutive calendar years worked and years of benefit service. The benefit formula is 1.50% of average compensation times benefit service, to a maximum of 20 years. When a participant chooses early retirement, the benefit earned is reduced by a specified percentage. Effective December 31, 2012, all benefit service and average compensation were frozen, and the benefit to which a participant is eligible, was the benefit accrued as of the freeze date.

Upon the decision to terminate the Plan effective March 31, 2024, participants were provided the opportunity to elect a lump-sum distribution or an annuity purchased from an insurance company.

**Death and disability benefits:** No disability benefits, other than those payable upon termination of employment, are provided in the Plan. The death benefit provided under the Plan shall be the minimum spouse's death benefit. The minimum spouse's death benefit is the death benefit for a vested married participant payable in the form of a pre-retirement survivor annuity. In the case of an unmarried participant or unmarried former participant who dies prior to the participant's retirement date, no death benefits shall be payable under the Plan.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** In 2024, management determined that liquidation of the Plan was imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared as a going concern on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and accumulated plan benefits, and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments as of December 31, 2024 are reported at liquidated value due to the Plan termination discussed in Note 10. Fair value approximates the amount the Plan expects to collect at liquidation. See Note 5 for discussion of fair value measurements.

The Plan's investments as of December 31, 2023 are stated at fair-value. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

The Plan presents in the statements of changes in net assets available for benefits in liquidation the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains and losses and the unrealized appreciation and depreciation on those investments.

**Administrative expenses:** Certain administration functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some Plan administrative expenses for investment and trustee services are paid directly by the Plan. Fees for recordkeeping, audit and other ancillary services are paid by the Plan Sponsor.

The 2024 financial statements include \$200,000 of accrued administrative costs for future expenses the Plan expects to incur through the final liquidation.

**Actuarial present value of accumulated plan benefits:** Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered through the date of the Plan freeze. Accumulated plan benefits include benefits expected to be paid to: (1) retired or terminated employees or their beneficiaries, (2) beneficiaries of employees who have died and (3) present employees or their beneficiaries.

The actuarial present value of accumulated plan benefits is determined by actuaries and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had valuations been performed as of December 31 there would be no material differences.

Management determined liquidation to be imminent during 2024. As a result, the consulting actuary calculated the actuarial present value of accumulated plan benefits as of December 31, 2024, using liquidation assumption prepared as of January 1, 2025.

#### Note 3. Funding Policy

The Plan Sponsor's pension contribution and Plan funding are determined as an amount to meet the minimum required contribution under the Internal Revenue Code (IRC) and to meet the minimum funding requirements of the Employee Retirement Income Security Act of 1974 (ERISA). The actuarial cost method prescribed by the Pension Protection Act of 2006 (PPA) was used to determine the target normal cost, funding target, and the minimum required contribution. The minimum required contribution was \$0 in 2024. The Plan Sponsor did not contribute to the Plan in 2024.

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

#### Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the carrying amount which approximates fair value.

**Exchange-traded funds:** Valued at the closing price reported on the active market on which the funds are traded.

**Corporate bonds:** Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

**U.S. government securities:** Valued by using pricing models maximizing the use of observable inputs for similar securities.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

#### Note 6. Related-Party and Party-in-Interest Transactions

Matrix Trust Company is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. The Plan Sponsor also paid certain administrative expenses of the Plan.

#### Note 7. Tax Status

The Internal Revenue Service has determined and informed the Sponsor, by a letter dated July 10, 2012, that the Plan and the trust established under the Plan is tax exempt under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits in liquidation.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### Note 10. Plan Termination

Management determined liquidation was imminent in 2024. On November 3, 2023, the Board of Directors of the Plan Sponsor passed a resolution to terminate the Plan effective March 31, 2024 and approved a plan of liquidation. Total lump-sum payments made in conjunction with the plan termination during the period from January 1, 2024 to December 31, 2024, were \$5,539,013. These amounts are included in benefits paid to participants in the statement of changes in net assets available for benefits in liquidation.

In November 2024, a single-premium non-participating group annuity contract (Contract) was purchased from plan assets from American National Insurance Company (American National) in the amount of \$18,941,404. The remaining 2024 annuity payments were made by the Plan in 2024 and benefit payments by American National began as of January 1, 2025. The Contract provides that American National has the obligation to pay all benefits under the Contract without change and in accordance with the elections that were made at the time benefit payments began. In August 2025, it was determined that a premium adjustment was due from American National in the amount of \$297,416. That amount was recorded on the statement of net assets available for benefits as Other Receivables as of December 31, 2024 and netted against Purchase of Annuity Contracts on the statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024.

The remaining Plan assets will be transferred to the NANA Regional Corporation, Inc. Compensation Deferral Plan in order to fund a qualified replacement plan. Transfers to the NANA Regional Corporation, Inc. Compensation Deferral Plan totaled \$9,597,679 during 2025.

#### Note 11. Pension Protection Act

The PPA, as amended by the Worker, Retiree and Employer Recovery Act of 2008 (WRERA) imposes certain benefit restrictions for qualified defined benefit plans that do not meet certain funding thresholds. The At-Risk status is referred to as the Funding Target Attainment Percentage (FTAP). A Plan's funded percentage is referred to as the Adjusted Funding Target Attainment Percentage (AFTAP). The 2024 and 2023 AFTAP for the Plan is 139.13% and 126.56%, respectively. Because the Plan's AFTAP is equal to or exceeds 80%, the Plan is not subject to any benefit restrictions.


