Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pepsi MidAmerica 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

Note 1. Description of the Plan

The following description of Pepsi MidAmerica 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering all full-time, nonunion employees of Pepsi MidAmerica (the Company) and its affiliated companies, Crisp Realty Co. and Crisp Container Company. Under the Plan, an employee becomes eligible to participate in the Plan and to receive discretionary matching contributions after completing one year of service, as defined. Employees are entered into the Plan the first day of the calendar month, coincident with or next following the date satisfaction of eligibility requirements are met. The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and investment options: Participants may elect to reduce their salary and have that amount contributed to the Plan. The elective deferred amount may not be more than the lesser of: (a) 100% of their annual compensation, (b) the maximum dollar amount allowed under the requirements of the Internal Revenue Code (IRC) (\$23,000 for 2024) or (c) such lesser amount as determined by the discrimination tests for the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (up to \$7,500). Participants may begin elective pretax and Roth deferral contributions on the first day of the month subsequent to the date they satisfy the eligibility requirements of the Plan. Rollover contributions from another qualified plan are permitted as defined in the Plan. The Plan includes an automatic enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set to 2% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Effective December 1, 2024, the Company amended the Plan to increase the automatic deferral percentage to 4%.

Each year, the Company contributes to the Plan amounts determined at the discretion of the Company's Board of Directors. Matching discretionary contributions are made for all participants who were active as of the last day of the plan year. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 0.25% of each 1% of each participant's salary deferral, up to a maximum contribution of 1% of the participant's gross wages. Matching contributions are subject to certain IRC limitations.

The amounts contributed by participants and the Company are deposited into a variety of pooled separate accounts and a guaranteed interest account per participant elections. Participants may change their investment elections at any time.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions, plus earnings thereon. Vesting in the Company's discretionary matching contributions plus earnings thereon is based on years of continuous service. One year of vesting service is earned for each service period in which a participant has worked 1,000 hours. A participant vests 100% in employer matching contributions immediately after three years of service. Prior to three years of service, a participant is 0% vested.

Notes to Financial Statements

Note 1. Description of the Plan (Continued)

Payment of benefits: On termination of service for reasons other than death, the employer may elect to permit plan distributions to be made in a lump-sum amount if the participant's vested account balance is less than \$7,000. For account balances greater than \$7,000, the participant may elect to receive the value of his or her account in an annuity or have the balance rolled over into an individual retirement account or other qualified plan. If a participant dies, a death benefit equal to the value of the participant's account is paid to the participant's beneficiary. Withdrawals other than for termination are permitted under circumstances provided by the Plan, including hardship withdrawals, and upon attaining age 59½ while continuing to work.

Forfeited accounts: Forfeited nonvested accounts are used to reduce future employer contributions and to pay plan expenses. For the 2024 plan year, \$12,402 of forfeited nonvested accounts were used to reduce employer contributions. At December 31, 2024 and 2023, the amount of forfeited nonvested accounts available for future use was \$0.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the underlying participant compensation is earned.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events for recognition and disclosure through January 12, 2026, which is the date the financial statements were available to be issued.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower), the custodian of the Plan, as agent for Talcott Resolution Life Insurance Company, the insurance issuer of the Plan, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares in each account held by the Plan at year end. The net asset value is not a publicly-quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimating fair value.

In accordance with the Fair Value Measurement Topic, investments that were measured at NAV per share have not been classified in the fair value hierarchy.

- (a) Seek to achieve the following objectives to varying degrees, depending on the proximity to their target date: growth, income and conservation of capital, to balance total return and stability over time. The funds invest primarily in growth, growth-and-income, equity-income, balanced and fixed income funds.

- (g) Seeks long-term growth of capital, current income and/or capital appreciation. The funds invest primarily in common stocks of small-capitalization companies and dividend paying companies.
- (h) Seeks total return through growth of capital and current income. The fund invests primarily in securities of real estate and real estate-related issuers, and may also invest in debt securities.

Note 5. Fully Benefit-Responsive Investment Contract

In 2012, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company (Talcott) totaling \$885,685 and \$950,446 as of December 31, 2024 and 2023, respectively. Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Talcott, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without consent of the issuer.

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8. Related Party and Party-in-Interest Transactions

Empower is the custodian and recordkeeper of the Plan and Talcott Resolution Life Insurance Company is the insurance provider of the Plan; therefore, transactions between them and the Plan qualify as party-in-interest transactions. The Company also paid certain administrative expenses of the Plan.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Nonexempt Transactions

During 2023, the Company inadvertently failed to deposit \$1,914 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Company deposited lost earnings to correct this failure in 2024.
