To Whom It May Concern:

We are submitting the **late Form 5500 Annual Return/Report for the Plan Year ending December 31, 2024**, along with all required schedules and attachments.

This filing is late due to circumstances beyond our control and despite our reasonable business efforts. The company **ceased operations in 2023** and terminated all employees. Participants were instructed to roll over their plan balances, and our third-party administrator at the time, Paychex, was responsible for handling the final distributions and annual compliance filings. Because the business and payroll systems were shut down and company email accounts were deactivated, we **never received notification or draft filings from Paychex**. As a result, we were unaware that the 2024 5500 had not been prepared or filed.

Once we became aware of this oversight in early 2026, we took immediate action to assemble the necessary information and complete the required filing. We have also confirmed that the plan is in the process of final termination, with the **final 5500 scheduled for 2025 to be filed before March 2, 2026**.

In support of this request for penalty relief due to **reasonable cause**, we respectfully offer the following:

1. **Cause was outside our control:** The employer had ceased operations, employee email accounts were deactivated, and critical communications from the administrator were not received, preventing timely awareness of the filing obligation.
2. **We exercised ordinary business care and prudence:** We relied in good faith on our administrator to manage compliance filings. We acted responsibly to terminate the plan and notify participants.
3. **Prompt corrective actions:** Upon discovery of the missing filing, we immediately engaged a qualified benefits professional to prepare and submit the 2024 return and ensure future compliance.
4. **Steps to prevent recurrence:** We have established new procedures and contacts for final plan administration and reporting to avoid similar issues.

Given these facts and acting in good faith, we respectfully request **abatement of all penalties connected with the late 2024 Form 5500 filing.**
