## Notes to Financial Statements

### Note 1. Description of the Plan

The following description of the Katcef Brothers, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Katcef Brothers, Inc. and its two affiliates Capital Eagle, Inc. and Montgomery Eagle, LLC (collectively, the Plan Sponsor or the Company) who have at least one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The President is responsible for oversight of the Plan. The Plan has an investment advisor that determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Company is the Plan Administrator. Charles Schwab Trust Bank is the Plan custodian of the Plan's assets, as well as Broadridge Retirement & Workplace, Inc. (Matrix Trust Company), a sub-custody partner of Charles Schwab Trust Bank. During 2023 and through November 14, 2024, Newport Group was the Plan's recordkeeper. Ascensus acquired Newport Group in 2022 and effective November 14, 2024, Newport transitioned into one recording platform under Ascensus.

#### Eligibility

To be eligible to participate in the Plan with respect to elective deferrals and matching contributions, employees of the Plan Sponsor must be at least 21 years of age and have completed one year of service.

#### Contributions

Each year, participants may contribute up to 75 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor contributes 50 percent of the first 4 percent of eligible compensation that a participant contributes to the Plan. The Plan Sponsor may also make a discretionary non-elective contribution (or discretionary profit-sharing contribution) each year on behalf of participants. During the years ended December 31, 2024 and 2023, the Company made matching contributions of \$112,887 and \$112,748, respectively. There were no discretionary non-elective contributions during 2024 or 2023.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Services (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and the allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### Vesting

Participants are vested immediately in their deferral contributions and their rollover account plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant begins vesting at two years of service and is vested in discretionary non-elective profit-sharing contributions according to the following schedule:

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50 percent of their vested account balance, whichever is less. A participant may have no more than two outstanding loans at any given time. The loans are secured by the balance in the participant's account and bear interest at rates equal to 1% above the prime rates. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump sum cash payment or installment payments as defined in the Plan document. In addition, upon attaining age 59 ½ or incurring a substantial financial hardship, a participant may request an in-service distribution in an amount equal to the value of the participant's vested interest in his or her account.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$16,944 and \$4,554, respectively. These accounts will be used to pay Plan expenses and, in some cases, remaining forfeitures will be used to reduce Company contributions. During 2024 and 2023, no forfeitures from nonvested accounts were used to reduce plan expenses or pay Company contributions.

## Note 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

## **Notes to Financial Statements**

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants after March 15 of the related subsequent year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Reclassifications**

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on the changes in net assets available for benefits.

### **Plan Management's Review of Subsequent Events**

The Plan has evaluated subsequent events through February 2, 2026, the date the financial statements were available to be issued.

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported. These investments held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. These investments held by the Plan are deemed to be actively traded.

Interest-bearing cash: a bank institutional money market deposit and a money market sweeping account, valued at cost, which approximates fair value.

Self-directed brokerage accounts: Accounts primarily consist of registered investment companies, common stocks, corporate bonds, U.S. Treasury securities, and interest-bearing cash. Registered investment companies, common stocks, and U.S. Treasury securities are valued using quoted market prices in active markets. Corporate bonds are valued using recently executed transactions, market price quotations (where observable), bond spreads or credit default swap spreads obtained from independent external parties such as vendors and brokers adjusted for any basis difference between cash and derivative instruments. The spread data used are for the same maturity as the bond. If the spread data do not reference the issuer, then data that reference a comparable issuer are used. When position-specific external price data are not observable, fair value is determined based on either benchmarking to similar instruments or cash flow models with yield curves, bond or single-name credit default swap spreads and recovery rates as significant inputs. The interest-bearing cash is a bank institutional money deposit, valued at cost, which approximates fair value.

#### **Note 5. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are held by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian, Broadridge Retirement & Workplace, Inc. (Matrix Trust Company), is a sub-custody partner of Charles Schwab Trust Bank, and Ascensus is the record keeper for the Plan, and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

## Notes to Financial Statements

### **Note 7. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated December 31, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
