INDEPENDENT AUDITORS' REPORT

To the 401(k) Plan Committee of the Cold Spring Brewing Company 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Cold Spring Brewing Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 27, 2025 and December 31, 2024, the related statements of changes in net assets available for benefits for the period from January 1, 2025 to June 27, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of June 27, 2025 and December 31, 2024, and for the period from January 1, 2025 to June 27, 2025 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with generally accepted accounting principles in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with generally accepted auditing standards in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

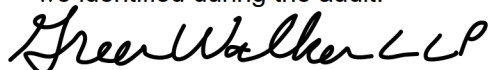
In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

FOR THE PERIOD FROM JANUARY 1, 2025 TO JUNE 27, 2025

AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the Cold Spring Brewing Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination – Effective June 27, 2025, all contributions into the Plan were suspended and the participants were immediately able to participate in the Carolina Beverage Group, LLC 401(k) Plan ("Successor Plan"). All assets of the Plan were transferred to the Successor Plan on June 27, 2025 and the Plan was terminated the same day.

General - The Plan was a defined contribution plan covering all employees of Cold Spring Brewing Company (the "Employer"), who were at least twenty-one years old, had provided six months of service, and were not classified as union employees, non-resident aliens, or residents of Puerto Rico. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The 401(k) Plan Committee was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions - Each year, participants could contribute up to 100% of their annual eligible compensation, as defined in the plan document, as a pre-tax or a Roth contribution. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Employer made safe harbor matching contributions of 100% of the first 4% of the participant's eligible compensation contributed to the Plan. The Employer could also make discretionary non-elective contributions. For the period from January 1, 2025 to June 27, 2025 and for the year ended December 31, 2024 there were no discretionary non-elective contributions to the Plan. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts - Each participant's account was credited with the participant's contributions and the Employer's safe harbor matching contributions, as well as allocations of the Employer's discretionary non-elective contributions and the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Vesting - Participants were immediately vested in their contributions and the Employer's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Employer's discretionary non-elective contributions plus actual earnings thereon was based on years of service. A participant was fully vested when they attained normal retirement age. Prior to normal retirement age, a participant's interest in the Employer's discretionary non-elective contributions, plus actual earnings thereon, were vested 20% after two years of service, increasing 20% each succeeding year until fully vested after six years of service.

Notes Receivable from Participants - Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above the bank prime rate, as defined in the plan document. Principal and interest were paid ratably through monthly payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over an elected period of time. For termination of service for some other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution. Benefits from the Plan could also be made upon proper application by a participant for proven financial hardship.

Forfeited Accounts - Benefit payments to terminated participants partially vested in the Plan include their vested portion of the Employer's discretionary non-elective contributions. The nonvested portion of the terminated participants' account balances were used to reduce the Employer's future contributions or to pay the Plan's administrative expenses as determined by the Employer at its sole direction. As of June 27, 2025, there were no forfeited nonvested accounts. As of December 31, 2024, forfeited nonvested accounts totaled approximately \$1,200. For the period from January 1, 2025 to June 27, 2025 and the year ended December 31, 2024, forfeited nonvested accounts totaling approximately \$1,200 and \$11,000, respectively, were used to either reduce the Employer's contributions or pay the Plan's administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the liquidation basis of accounting.

Use of Accounting Estimates - The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("GAAP") required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts were recognized in the year in which such adjustments were determined.

Investment Valuation and Income Recognition - Investments were reported at fair value, except for the fully benefit-responsive guaranteed interest account, which was reported at contract value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The Plan's 401(k) Plan Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and Empower Annuity Company of America and Empower Trust Company, LLC, the Trustees of the Plan. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from participants were recorded as they are withheld from the participant's wages. Contributions from the Employer were recorded in the period in which the related participant contributions were due.

Notes Receivable from Participants - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses was recorded as of June 27, 2025 and December 31, 2024. If a participant ceased to make loan repayments and management deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits - Benefits were recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses that were paid by the Employer were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events - Management has evaluated subsequent events through February 2, 2026, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY TRUSTEES

The following is a summary of the Plan's asset information as of June 27, 2025 and December 31, 2024, and for the period from January 1, 2025 to June 27, 2025 and for the year ended December 31, 2024, respectively, included in the financial statements, that was prepared by, or derived from, information prepared by the Trustees and furnished to management. Management has obtained certifications from the Trustees that such information is complete and accurate as of June 27, 2025 and December 31, 2024 and for the period from January 1, 2025 to June 27, 2025 and as of and for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

GAAP provided the framework for measuring fair value by utilizing a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 Inputs to the valuation methodology included:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability;
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of June 27, 2025 and December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustees, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described could produce a fair value calculation that may have not been indicative of net realizable value or reflective of future fair values. Furthermore, although management believed the Plan's valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could have resulted in a different fair value measurement as of the reporting date.

5. GUARANTEED INTEREST ACCOUNT

On November 16, 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Company of America ("Empower") totaling \$440,520 as of December 31, 2024. Empower maintained the Plan's investment in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 0%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participant.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain investments of the Plan were managed by Empower Annuity Company of America and Empower Trust Company, LLC. Empower Annuity Company of America and Empower Trust Company, LLC were the Trustees and recordkeepers for the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions.

As described in Note 1, the Plan permitted participants to borrow from their account balances. These transactions qualified as exempt party-in-interest transactions.

7. TAX STATUS

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualified under Internal Revenue Code ("IRC") Section 401(a). The Plan had not received a determination letter specific to the Plan itself; however, management and the Plan's tax counsel believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and, therefore, that the Plan was qualified, and the related trust was tax exempt.

GAAP required management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management had analyzed the tax positions taken by the Plan, and has concluded that as of June 27, 2025 and December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits of any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
