## Notes to Financial Statements

April 30, 2025 and 2024

### **1. Description of the Plan**

The following description of the Smith & Wesson Brands, Inc. Profit Sharing and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan available to eligible employees of Smith & Wesson Brands, Inc., Smith & Wesson Sales Company, Smith & Wesson Inc. and SWPC Plastics, LLC (collectively, the Employer) who are age 18 or older. Union, leased, employees of a controlled group that do not adopt the Plan, part-time and seasonal employees working less than 1,000 hours in a year and any employee who receives only pension, service pay, retainer or fee under contract (independent contractors, consultants and interns) are generally excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Smith & Wesson Brands, Inc. is the Plan administrator and responsible for monitoring of the Plan. Transamerica Retirement Solutions, LLC (Transamerica) is the third-party administrator of the Plan and Transamerica Trust Company (TTC) serves as the trustee. Prior to March 1, 2025, State Street Bank and Trust Company (State Street) was the Plan trustee.

#### **Fiscal Year-End**

The Plan operates on a fiscal year ending April 30. All references in these financial statements refer to the fiscal year-end unless otherwise stated.

#### **Contributions**

Each year, participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, increasing annually by 1% up to maximum deferral rate of 6%.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### Contributions (continued)

The Employer may make discretionary matching and nonelective contributions to the Plan. For 2025 and 2024, the Employer elected to make matching contributions equal to 50% of the employee's contributions up to 6% of the employee's compensation. In addition, for the years ended April 30, 2025 and 2024, the Employer elected to make nonelective contributions totaling \$4,626,419 and \$9,098,303, respectively. Participants are eligible to receive nonelective contributions if they are employed on the last day of the Plan year and have completing two years of service. Prior service with Thompson/Center Arms Company, Inc. will count for purposes of determining eligibility, vesting and Employer contribution allocations. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's discretionary matching and nonelective contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions and discretionary nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's discretionary matching contribution portion of their accounts plus related earnings thereon is based on years of vesting service in which the participants complete 1,000 hours of service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	50%
2 or more	100%

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set to a reasonable rate, as defined. Principal and interest are paid ratably through payroll deductions.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### Payment of Benefits

On termination of service due to death, disability or early retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

#### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan and are considered nonparticipant-directed investments. Forfeitures may be used to pay administrative expenses and to reduce future Employer contributions. During 2025 and 2024, Employer contributions were reduced by \$40,560 and \$49,215, respectively, from forfeited non-vested accounts. As of April 30, 2025 and 2024, forfeited non-vested accounts held in the cash reserve account total \$40,488 and \$34,884, respectively.

### 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for its benefit-responsive investment contract, which is valued at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **2. Significant Accounting Policies (continued)**

##### **Contributions**

Contributions from Plan participants and the discretionary matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of April 30, 2025 or 2024. If a participant ceases to make scheduled repayments and the Plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment recorded.

##### **Benefits Paid to Participants**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### **Reclassifications**

Certain amounts in the prior year have been reclassified to conform with 2025 classifications.

##### **Subsequent Events**

The Plan has evaluated subsequent events through January 27, 2026, the date the financials were available to be issued.

#### 3. Certified Investments

TTC held the Plan's investment assets and executed investment transactions from March 1, 2025 through April 30, 2025, and State Street held the Plan's investment assets and executed investment transactions as of April 30, 2024, and for the period from May 1, 2024 through February 28, 2025. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of April 30, 2025 and 2024, and net appreciation in fair value of investments, interest income from stable value fund, dividend and interest income and interest income on notes receivable from participants for the years ended April 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TTC and State Street.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Cash reserve account:* Interest-bearing savings account maintained by State Street.

*Collective investment trust:* Valued at the NAV of shares held by the Plan at year end. Although the collective investment trusts are not available in an active market, the NAV of units is approximated based on the observable inputs of the underlying investments and are traded in an active market.

#### 5. Guaranteed Investment Contract

The Plan invests in a fully benefit-responsive investment contract with Prudential Life Insurance Company (Prudential) totaling \$28,870,383 and \$30,022,664 as of April 30, 2025 and 2024, respectively. Prudential maintains the contributions in a general unallocated account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective crediting rate is fixed and is established quarterly on January 1, April 1, July 1, and October 1 of each year is based on the daily balance, at a rate that is the daily equivalent of the effective annual credit rate applicable for the three-month period. The crediting rate will not be below 0%.

#### **5. Guaranteed Investment Certificate (continued)**

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include intentions to terminate the Plan, the Plan become unqualified, intentions to merge the Plan, or a material uncured breach in the Contract occurs.

#### **6. Related Party Transactions and Party-in-Interest Transactions**

Fees paid by the Plan to Transamerica qualify as party-in-interest transactions. Notes receivable from participants and participant contributions are also considered to be party-in-interest transactions. Employer contributions are considered to be both party-in-interest and related party transactions.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

#### **8. Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan which had received an opinion letter dated June 30, 2020, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. Risks and Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
