Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance, and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material, if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Community, Counseling and Correctional Services, Inc. 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a single employer, defined contribution plan and has a savings feature that is commonly known by the terms of "cash" or "deferred" or "401(k)" covering all employees of the Plan sponsor, Community Counseling and Correctional Services, Inc. (the Company) who have attained age 18 and completed one month of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

Participant Contributions Participants may elect to contribute pre-tax or ROTH contributions to the Plan. Each year, participants may contribute up to the lesser of seventy-five percent (75%) of eligible compensation or the limit established by the Internal Revenue Service (IRS). For calendar years 2025 and 2024, the limit is \$23,500 and \$23,000, respectively. Individuals who will be age 50 by the end of the calendar year may make additional catch-up contributions to the Plan. For calendar years 2025 and 2024, the maximum catch-up contribution is limited by the IRS to \$7,500.

Matching Contributions Participants with at least one year of continuous service are eligible to receive Company matching contributions when offered. Company matching contributions are discretionary and are determined by the employer annually. Matching contributions were equal to one hundred percent (100%) of participants' deferrals up to six percent (6%) of eligible compensation during plan years 2025 and 2024. Employees are provided notice of any change in the Company matching contribution at least 30 days prior to effective date of the change.

Discretionary Contributions Profit sharing contributions are discretionary. There were no discretionary profit sharing contributions for the years ended June 30, 2025 and 2024.

Rollovers The Plan accepts qualified rollover contributions from qualified sources.

Participant Accounts Each participant's account is credited with the participant's contributions and Company matching contributions and an allocation of (a) discretionary contributions (when applicable) and (b) Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately 100% vested in their pre-tax, ROTH, and rollover contributions, plus actual earnings thereon. Vesting in the Plan sponsor's contribution portion of their accounts is based on years of service with the Plan sponsor. For vesting purposes, a year of service is a plan year during which the participant is credited with at least 1,000 hours of service. A participant is 100% vested after six years of credited service.

For a participant who is re-employed after a break in service of less than five years, the years of service both prior to and following the break are counted when determining the participant's vested account balance.

Payment of Benefits If the vested account balance of a terminated participant is less than \$7,000, the participant may receive a cash distribution of the value of the entire vested portion of such account balance without participant consent. When a terminating participant does not make a timely election with respect to the cash distribution of amounts greater than \$1,000, but less than \$7,000, the Plan administrator will make a direct rollover to an individual retirement account or annuity (IRA). The Plan administrator will select the IRA trustee or custodian, establish the IRA and make the initial IRA investment selection. If the account exceeds \$7,000, all or a portion of the balance may be distributed, upon written request by the participant, as a lump sum, installment payments, or a combination of lump sum and installment payments. There are no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid as of June 30, 2025 and 2024.

Forfeitures Account balances forfeited under the vesting schedule can be used to reduce Plan sponsor contributions in the subsequent plan year and to pay Plan administrative expenses. During the Plan years ended June 30, 2025 and 2024, forfeitures applied to Plan sponsor matching contributions were \$19,258 and \$7,513, respectively. At June 30, 2025 and 2024, there were \$2,907 and \$413, respectively, of unapplied forfeitures.

Plan Termination Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company contributions.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's Board of Directors and Plan administrator determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Common Trust: The common trust maintained by Invesco Trust Company, a party in interest, is a pool of investments of which the Plan buys and sells units of participation that generally imitate established mutual funds. The underlying investments consist of a common trust which holds primarily U.S. Treasuries securities, corporate bonds, mortgage backed securities, and asset backed securities. The Plan's valuation estimates are based on the contract and market values of the underlying investments using the practical expedient. Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the common trust, Invesco Trust Company reserves the right to temporarily delay withdrawal from the trust, in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at June 30, 2025 and 2024.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Excess Contributions Payable Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions were \$-0- and \$4,096 for the years ended June 30, 2025 and 2024, respectively.

Payment of Benefits Benefits are recorded when paid.

Expenses Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements and include audit and miscellaneous administrative fees. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through January 27, 2026, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included in the statements of net assets available for benefits, and the investment income included in the statements of changes in net assets available for benefits as of and for the years ended June 30, 2025 and 2024, were not subject to auditing procedures and have been certified as complete and accurate by Reliance Trust Company. Reliance Trust Company is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

There were no transfers into or out of level 3 investments for the years ended June 30, 2025 and 2024. The Plan's policy is to recognize transfers into and out of level 3 as of the actual date of the event or change in circumstances.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by ADP. ADP is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

ADP provides certain administrative services to the Plan pursuant to an agreement between the Company and ADP. ADP receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to ADP for its administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by ADP from investment providers exceeds the amount owed under the service agreement, ADP remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company may make a payment to ADP for administrative expenses not covered by revenue sharing.

Royal Alliance Associates, Inc. provides investment advisory services to the Plan. Fees paid by the Plan for these services are included in administrative expenses on the statements of changes in net assets available for benefits.

6. TAX STATUS

The Plan sponsor adopted the ADP Defined Contribution Non-Standardized 401(K) Profit Sharing Plan Basic Plan Document. ADP received a favorable determination letter from the IRS concerning this plan document dated October 6, 2020, indicating that the Plan and related trust, as then designed, are in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
