### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of the Guthrie Theater Foundation 403(b) Retirement Plan (formerly 403(b) Thrift Plan for Employees of Guthrie Theater Foundation), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Guthrie Theater Foundation 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of March 31, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Guthrie Theater Foundation 403(b) Retirement Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

***Basis for Disclaimer of Opinion***

The Guthrie Theater Foundation 403(b) Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 4 to the financial statements, the Guthrie Theater Foundation 403(b) Retirement Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

***Emphasis of Matter – Basis of Accounting***

We draw attention to Note 2 to the financial statements which describe the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Guthrie Theater Foundation 403(b) Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Guthrie Theater Foundation 403(b) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) – modified cash basis as of March 31, 2025 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Guthrie Theater Foundation 403(b) Retirement Plan (formerly 403(b) Thrift Plan for Employees of Guthrie Theater Foundation) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 1989. The Plan was last amended and restated effective July 8, 2024 to change the Plan name. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

The Plan covers substantially all employees of Guthrie Theater Foundation (the Employer), as defined in the Plan, except nonresident aliens with no U.S. source income and leased employees. Employees are eligible to participate in the salary reduction arrangement of the Plan on the first day of the payroll period coinciding or immediately following date of hire. Employees are eligible for Employer matching and base contributions after they attain age 21 and complete one year of service with the Employer provided they are not receiving a retirement plan contribution from the Employer under a separate union or other contractual arrangement.

**Contributions**

Participants may contribute to a salary reduction account on a pre-tax or post-tax basis up to the maximum permitted by the Internal Revenue Code (IRC). Participants who are age 50 or older as of the end of the Plan year are eligible to make catch-up contributions.

The Employer will make a matching contribution to the Plan equal to 150% of salary deferral contributions, up to a maximum of 4.5% of eligible compensation when an employee makes salary deferrals of 3% or greater. In addition, the Employer makes a base contribution equal to 1% of eligible compensation regardless of whether or not the employee contributes to the Plan. Employees who are actors, musicians, or overhires are not eligible for Employer matching and base contributions. Also, highly compensated employees (except the Artistic Director) are not eligible for Employer matching contributions to this Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit IRAs (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer matching and base contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

Participants are immediately vested in all contribution sources, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested non-Roth account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Plan Loans**

Plan loans may be requested by a participant using their account as collateral for the loan. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits – modified cash basis. Plan loans may not exceed the lesser of (i) \$50,000 or (ii) 50% of the participant's account. Loans may be further limited by the funding vehicles.

Plan loans are issued directly from the funds owned by TIAA and CREF or Mutual of America and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity or Mutual of America Interest Accumulation account balance is reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan is outstanding. For active loans, investments equal to 110% of the outstanding loan amount are reflected in the statements of net assets available for benefits - modified cash basis and serve as collateral for the loan. Investments underlying the defaulted loan balances are reflected in the statements of net assets available for benefits – modified cash basis until a distribution event occurs.

As of March 31, 2025 and 2024, there were \$-0- and \$8,527, respectively, of investments held within participant accounts in the TIAA Traditional Annuity Account and/or the Mutual of America Interest Accumulation Account, which served as collateral against outstanding plan loan balances.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of an annuity or lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and for hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. Effective July 8, 2024, if the account balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan administrator will authorize that the balance be rolled into an IRA in the participant's name.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under that basis, certain additions are recognized when received and certain deductions are recognized when paid. Investments are stated at fair value. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America primarily because the effects of outstanding contributions and outstanding expenses are not included in the financial statements.

**Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 and 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain investment management fees are netted with investment income. These fees are charged to the individual participant's accounts. All other administrative expenses are paid by the Employer.

**Subsequent Events**

The Plan has evaluated subsequent events through January 28, 2026, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Voya Retirement Insurance and Annuity Company and Voya Institutional Trust Company, the qualified institutions of the Plan effective July 8, 2024, have supplied the Plan administrator with certifications as to the completeness and accuracy of certain investment information presented on the accompanying statement of net assets available for benefits – modified cash basis as of March 31, 2025, the supplemental schedule of assets (held at end of year) – modified cash basis as of March 31, 2025, and the related investment activity reflected in the statement of changes in net assets available for benefits – modified cash basis for the period from July 8, 2024 through March 31, 2025.

Mutual of America Life Insurance Company, and TIAA and CREF, the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of certain investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits – modified cash basis as of March 31, 2025 and 2024, the statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the supplemental schedule of assets (held at end of year) – modified cash basis as of March 31, 2025.

**NOTE 4 HISTORICAL PLAN ADMINISTRATION**

On January 1, 1989, the Employer originally adopted the Plan. On April 1, 2010, the Plan document was restated in its entirety to conform to new regulatory changes. Historically, the Plan was viewed as an amalgamation of individual annuity and custodial accounts and the Plan and its custodian (TIAA-CREF) did not maintain financial information at a plan level. As of December 31, 2008, TIAA-CREF began to provide the Plan administrator with annual certified statements summarizing the Plan's activities and holdings. Because certain historical records were not maintained or are not available at a plan level, the Plan has excluded from investments in the accompanying statements of net assets available for benefits (modified cash basis) certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009.

This accounting policy election is permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans (FAB 2009-2); however, the modified cash basis of accounting requires that these accounts and the related income and distributions be included in the accompanying financial statements. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable.

**NOTE 5 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at March 31, 2025 and 2024

*Funds Held in Insurance Company General Accounts* – Investments in nonfully benefit responsive contracts are reported at fair value, which approximates contract value. As these investments are contract based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The fair value equals the accumulated cash contributions and interest credited, less any withdrawals. Liquidity restrictions apply to certain types of these contracts that could impact the value realized upon exiting the contract. See Note 6 for additional information.

*Interest in Subaccounts of Variable Annuity Contracts* – Valued at NAV of shares, which are valued by the insurance companies at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions (Level 2).

*Mutual of America Separate Account No. 2* – Valued at the NAV of units as determined by the insurance companies. NAV is a readily determinable fair value and is the basis for current transactions (Level 2).

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*General Fixed Account* – Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**NOTE 6 GUARANTEED INVESTMENT CONTRACTS**

The Plan offers a guaranteed investment contract with TIAA through the TIAA Traditional Annuity Account and Mutual of America through the Mutual of America Interest Accumulation Account. The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Choice Annuity (RC), Retirement Annuities (RA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. The Plan's TIAA Traditional Annuity holdings include RA, SRA, and GSRA contract types.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's board of trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA, the crediting interest rate was 5.25% as of March 31, 2025 and 2024. For accumulating SRA and GSRA contracts, the crediting interest rate was 4.50% as of March 31, 2025 and 2024.

The RA contract does not allow lump sum cash withdrawals, and transfers must be spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). Since the RA contracts have liquidity restrictions, they are considered nonbenefit responsive. The RC, SRA, and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in net assets available for benefits (modified cash basis).

The portion of the TIAA guaranteed investment contract that is fully benefit-responsive is reported at contract value. The remaining portion of the TIAA Traditional Annuity Account and all of the Mutual of America Interest Accumulation Account is nonfully benefit-responsive, and therefore fair value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents the accumulated cash contributions and interest credited to the Plan's participants, less any withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan Sponsor has determined that contract value approximates fair value for the portion of the guaranteed investment contract that is not fully benefit-responsive.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed investment contracts at March 31, 2025 and 2024 approximated fair value. The crediting interest rate is based on the underlying contracts between TIAA or Mutual of America and the plan participants, but generally it may not be less than 3% for the TIAA Traditional Annuity or 1% for the Mutual of America Interest Accumulation Account, and the potential for additional interest if declared by TIAA or Mutual of America. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable. Effective July 8, 2024, the Plan terminated its contract with Mutual of America; therefore, there is no balance in the Mutual of America Interest Accumulation Account as of March 31, 2025.

**NOTE 7 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

In 2024, the Plan entered into a group annuity contract with Voya Retirement Insurance and Annuity Company (Voya). As part of the contract, Voya maintains a portion of the contributions in a "guaranteed account." The account is credited with earnings on the underlying investments and is charged for Plan withdrawals and administrative expenses charged by Voya. The guaranteed account is included in the financial statements at fair value, because it is not fully benefit responsive.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

**NOTE 9 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, there would be no significant effect as participants are immediately vested in all contributions to their accounts.

**NOTE 10 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 403b of the IRC and is, therefore, not subject to tax under current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

The modified cash basis of accounting requires Plan management to evaluate if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 11 PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by Voya Retirement Insurance and Annuity Company, Voya Institutional Trust Company, Mutual of America Life Insurance Company, and TIAA and CREF, the qualified institutions of the Plan, therefore, the investment transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 12 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The Plan is invested in the Mutual of America Separate Account Number 2, pooled separate account, as classified in the financial statements included herein. The pooled separate account did not file a Form 5500 for the direct filing entity; therefore, the underlying assets have been reported on Form 5500, Schedule H, as mutual funds.
