### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the HOME OWNER SERVICES 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the HOME OWNER SERVICES 401(K) PLAN's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the HOME OWNER SERVICES 401(K) PLAN's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements, as a whole, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedules listed in the accompanying table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by Empower Trust Company, LLC, a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—PLAN DESCRIPTION**

The Home Owner Services 401(k) Plan (the “Plan”) is a defined contribution plan designed to operate under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees of American Water Resources LLC and Pivotal Home Solutions, LLC (collectively the “Company”) who are age 18 or older, other than those specifically excluded from participation as noted under “eligibility”. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The following description of the Plan provides only summary information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The effective date of the Plan was January 1, 2022. The Plan was amended and restated effective January 1, 2024.

**ELIGIBILITY**

Employees age 18 or older (other than those covered by a collective bargaining agreement, non-resident aliens, residents of Puerto Rico, interns, and part-time/temporary/seasonal/co-op program employees who work under 1,000 hours in a year) are eligible to make deferrals and rollovers to the Plan and receive Company matching and discretionary contributions.

**CONTRIBUTIONS**

Eligible employees may elect to defer up to 50% of eligible compensation on a pre-tax basis, after-tax basis (“Roth”), or a combination of both. These contributions are subject to certain limitations of the IRC. The maximum amount able to be deferred for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who are at least age 50 may make additional “catch-up” contributions. The maximum amount for the catch-up contributions was \$7,500 for 2024 and 2023. The Plan has the automatic enrollment feature which is set at 3%. Eligible employees who do not make their own elections are automatically enrolled in the Plan unless they elect not to be included. Participants may also roll over amounts representing distributions from other qualified plans. Roth monies may not be rolled into the Plan, however. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions equals to 100% of each participant’s elective deferrals, but not as to elective deferrals exceeding 4% of the participant’s compensation. The Company does not make matching contribution on catch-up contributions. The Company’s matching contributions were \$2,003,864 for 2024 and \$1,219,897 for 2023.

Based on the discretion of the Board of Directors, the Company may, subject to certain limitations, make profit sharing contributions to the Plan for each participant in accordance with the terms of the Plan document. The Company’s profit sharing contributions were \$2,477,422 and \$2,624,271 for 2024 and 2023, respectively.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, plan compensation, or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1—PLAN DESCRIPTION (Continued)**

VESTING

Participants are 100% vested in their elective deferrals, rollover contributions and Company matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after one year of credited service.

NOTES RECEIVABLE FROM PARTICIPANTS

Loans are permitted to be taken from the Plan, pursuant to the Plan's loan policy.

PAYMENT OF BENEFITS

Upon normal retirement, a participant may elect to receive a lump sum payment. Only partial installment distributions are permitted for required minimum distributions. An entire account balance can be paid to a beneficiary upon the death of a participant. Force-out distributions can be made for balances not exceeding \$5,000. In-service withdrawals can be taken for certain financial hardship circumstances.

FORFEITURES

Forfeited participants' Company contribution accounts can be used as additional Company contributions, to reduce Company contributions, or pay expense of the Plan. Forfeitures used to pay plan expenses were \$504 for 2024 and \$1,144 for 2023. Forfeitures available for future use were \$74,785 as of December 31, 2024 and \$48,302 as of December 31, 2023.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments at December 31, 2024 and 2023 were held by Empower Trust Company, LLC ("Empower").

## NOTES TO FINANCIAL STATEMENTS

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

## INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for investments with contract values. Contract value is the relevant measure for those investments because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Investments other than the EI Fixed Account – Series I Class are stated at fair value as of December 31, 2024 and 2023. In accordance with U.S. GAAP, this investment is excluded from the fair value hierarchy. Investments in mutual funds are valued at the net asset value of shares held by the Plan at year-end.

The EI Fixed Account - Series Class I (“Fund”) is a general account product. The Fund is stated at contract value (principal balances of the contracts, plus accrued interest at the stated rate, less payments received and contract charges by the insurance company), which is approximate fair value, as determined by Empower. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The actual average yield earned by the Plan for the Fund was 1.41% for 2024 and 1.23% for 2023.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

## NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

## PAYMENT OF BENEFITS

Benefits are recorded when paid.

## ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

*Level 2 and Level 3 Fair Value Measurements*

Level 2 and Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Common Collective Trust funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**NOTE 4—INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) for 2024 and 2023. Accordingly, Empower Trust Company, LLC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by Empower, the trustee of the Plan. Various fees are paid to Empower for these services, some of which are deducted from plan earnings. The Plan's investment advisor is also paid various fees from the Plan. Empower and the investment advisor are parties-in-interest.

**NOTE 6—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. If the Company should decide to terminate the Plan, participants would become 100% vested in the discretionary Company contribution portion of their accounts.

**NOTE 7—TAX STATUS**

The Plan has adopted the Empower Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan. Empower has obtained a letter from the Internal Revenue Service (IRS) dated November 14, 2022 which states that the non-standardized plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since the date of that letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 7—TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9—PROHIBITED TRANSACTIONS**

During 2023, the Company failed to transmit certain participant contributions within the timeframe required by DOL Regulation 2510.3-102 totaling \$111,948. Delays in remitting contributions to the Plan were due to administrative errors. The Company made contributions to the affected participants' accounts, including lost earnings to compensate those participants for potential lost income due to the delays during 2024.
