The Form 5500-SF was not filed on time due to the Employer filing for Chapter 7 bankruptcy. Dispenser Beverages Inc. filed Chapter 11 in the U.S. Bankruptcy Court Middle District of Florida (Tampa) on January 12, 2023. The case was converted to Chapter 7 on April 28, 2023.

It was not known that Form 5500-SF was required for this estate until it was notified of the filing requirement.
