## **Independent Auditors' Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of The Evan Group 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Evan Group 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Note 1: Description Of Plan**

The following description of The Evan Group 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted July 1, 1990 and is a defined contribution 401(k) plan established to provide retirement benefits for employees of Hamilton News Co., Inc. and Affiliates (the Companies). Eligible employees become participants in the Plan following one year of eligible service, after they work at least 1,000 hours from the first day of employment, and attainment of age 21, as defined in the Plan Agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants can contribute up to 90% of eligible compensation. Eligible employees who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions. Participants have the option of making after tax Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Companies may make a discretionary matching contribution each year to the Plan equal to a percentage of the amount contributed by participants. For the years ended June 30, 2025 and 2024, employer matching contributions were 25% of participants' contributions up to 6% of eligible compensation. All contributions are subject to Internal Revenue Code limitations.

Participants' accounts - Each participant's account is credited or charged with the participant's contributions and allocations of the Companies' discretionary contribution, plan earnings (losses), payments, withdrawals, expenses, or other distributions made to or from such accounts during the year. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting - Participants are 100% vested in their voluntary contributions, rollover amounts, any employer contributions, and investment earnings. Consequently, there are no forfeitures in the Plan.

Payment of benefits - On termination of service due to death, disability, retirement, or separation of service, a participant or their beneficiary will be entitled to receive a distribution of the participant's total vested account balance. Benefits will be paid in accordance with the terms of the Plan Agreement.

Plan termination - Although they have not expressed any intent to do so, the Companies have the right, under the Plan, to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account will be distributed in accordance with the Plan Agreement.

**Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Purchases and sales of securities are recorded on a trade-date basis with the gain or loss based upon the average-cost method. Interest income is recorded on an accrual basis. Dividends are recorded at the ex-dividend rate.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has adopted a prototype plan which has an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**Note 2: Summary Of Significant Accounting Policies (Continued)**

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year's financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on total net assets available for benefits or changes in net assets available for benefits.

**Note 3: Investments**

The statements of net assets available for benefits, the investment activities included in the statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024, and the accompanying notes to the financial statements were prepared entirely from information certified by Reliance Trust Company, the Trustee of the Plan from July 1, 2023 through June 30, 2024, and ADP Retirement Trust Services, LLC, the Trustee of the Plan from July 1, 2024 through June 30, 2025, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$5,627,476 and \$5,147,705 at June 30, 2025 and 2024, respectively, and related investment income of \$682,503 and \$847,843 for the years ended June 30, 2025 and 2024, respectively.

**Note 4: Fair Value Measurements**

The following is a description of the valuation methodology used for assets at fair value at June 30, 2025 and 2024:

*Mutual funds:* Valued at quoted market prices at year end.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**Note 5: Investments At Contract Value**

The Stable Value Fund Collective Investment Trust is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses) because it is fully benefit-responsive. For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

However, the contract generally provides that withdrawals associated with certain events which are not in the ordinary course of fund operations, and are determined by the issuer to have a material adverse effect on the issuer's financial interest, will be paid with a market value adjustment to the contract value amount of such withdrawal as defined in the contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Units of the Stable Value Fund Collective Investment Trust may be redeemed at any time and the contract contains no withdrawal penalty provisions.

**Note 7: Plan Amendments**

Effective April 1, 2024, the Plan was amended to allow Roth elective deferrals. A participant may elect to classify all or a portion of an elective deferral as a Roth Contribution.

**Note 8: Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of June 30, 2025, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

**Note 10: Subsequent Events**

Subsequent events have been evaluated through January 23, 2026, which is the date the financial statements were available to be issued.
