Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following description of the American Heating, Inc. ("the Company") 401(k) Plan ("Plan") provides only general information. Reference should be made to the Plan document for a more complete description of its provisions.

GENERAL. The Plan was established January 1, 1987, and is a defined contribution plan covering all eligible employees of the Company who have met certain age and period of service requirements. The Plan's Trustees manage the operation and administration of the Plan. Multnomah Group, Inc serves as the investment advisor. Mt Hood Pension Service LLC serves as the third-party administrator and record keeper. Empower Trust Company LLC serves as custodian and record keeper of the plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS. Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. The Company may contribute a discretionary match or discretionary profit sharing contribution to be determined annually by the Board of Directors. Employees are eligible for the discretionary match after three months of employment (250 hours of services) and are still employed at the end of the fiscal year. The employer matching contribution for the years ended September 30, 2025 and 2024 was \$309,457 and \$302,052, respectively. At the discretion of the plan administrator, forfeited accounts can be used to offset employer match contributions. For the years ended September 30, 2025 and 2024, \$8,393 and \$32,024 of forfeited accounts were used to offset employer matching contributions, respectively.

PARTICIPANT ACCOUNTS. Each participant's account is credited with an allocation of (a) employee elective deferrals, (b) the employer's discretionary matching contributions, as defined above, if any, and (c) Plan earnings. Item (a) is allocated based on participants' elective contributions. Items (b) and (c) are allocated based on participants' elective deferrals or account balances, as defined, and specified in the Plan agreement.

VESTING. Participants are fully vested in their rollover and elective contributions, plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, and upon death, disability or upon reaching normal retirement age.

EXPENSES. Generally, fees associated with the administrative expenses of the Plan include professional fees, office supplies, and payroll expenses of administrative and clerical personnel, and are provided for by the Company without charge to the Plan. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts.

PAYMENT OF BENEFITS. Upon termination of service a participant may elect to receive a lump-sum amount equal to the participant's vested account balance or roll their account balance to another company's qualified plan or IRA (if the balance exceeds \$5,000). At September 30, 2025 and 2024, there were no amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not been paid.

HARDSHIP WITHDRAWALS. Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need. They must be approved by the custodian on a nondiscriminatory basis.

FORFEITED ACCOUNTS. Forfeited accounts of unvested benefits are available to offset future employer contributions to the Plan. The non-vested forfeited accounts balance at September 30, 2025 and 2024 was \$14,486 and \$37,943, respectively. The forfeited accounts are being held in the fixed annuity fund.

1. DESCRIPTION OF THE PLAN - Continued

INVESTMENT OPTIONS. Upon enrollment, a participant may direct contributions to certain investment accounts selected by the Trustees and these investment allocations may be changed daily by participants. Participants may change their investment percentages at any time with an effective date of the next pay period or a future pay period of their choosing. Any modifications shall not have a retroactive effect and shall remain in force until revoked.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied to nongovernmental entities in the preparation of financial statements in conformity with accounting principles generally accepted in the United States of America.

BASIS OF ACCOUNTING. The accompanying financial statements have been prepared on the accrual basis of accounting.

USE OF ESTIMATES. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

VALUATION OF INVESTMENTS - MUTUAL FUNDS. Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the plan year, based on quoted market prices of the underlying securities and other financial instruments owned by each fund.

VALUE OF INVESTMENTS - FIXED ANNUITY FUND. The methodology for calculating the interest crediting rate on fixed annuity accounts is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. Plan management and the custodian consider the fund investments to not be considered fully benefit responsive at the Plan level.

INVESTMENT TRANSACTIONS. Purchases and sales of securities are recorded on the settlement date.

RISKS AND UNCERTAINTIES. The Plan provides for investment options primarily in mutual funds and fixed annuity fund, which invest in portfolios of investment securities through Empower Trust Company LLC, the custodian of the Plan assets. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

From time to time, investments may include securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of September 30, 2025 and 2024.

SUBSEQUENT EVENTS. The Plan has evaluated subsequent events through January 24, 2026, the date that the financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the *Fair Value Measurements* topic for financial assets and financial liabilities are described below:

Level 1	Values are based on quoted prices in active markets for identical securities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.
Level 3	Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs may reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset or financial liability.

Pursuant to the *Fair Value Measurements* topic of the FASB ASC, fair value is a market-based measure, considered from the perspective of a market participant who owns an asset or owes a liability. Accordingly, when market observable data is not readily available, assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

4. INCOME TAX STATUS

The Plan is utilizing a volume submitter as its plan document. The volume submitter obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in all their accounts.

6. INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN

The following summary of unaudited information regarding the Plan and included in the Plan's financial statements and ERISA-required supplemental schedule of assets held at end of year was certified by the custodian of the Plan, Empower Trust Company LLC, as of and for the periods ended September 30, 2025 and 2024. The information was furnished to the plan administrator and the plan administrator has obtained certification from the custodian that such information is complete and accurate.
