This letter is to confirm and specify the terms of our engagement with your plan for the plan year ended December 31, 2025 and to clarify the nature and extent of the services we will provide.

We will provide the following services to you for the plan year noted above:

1. Preparation of Form 5500

It is your responsibility to provide all the information required in a timely fashion. We will not audit or otherwise verify the data you submit, although it may be necessary to ask you for clarification of some of the information. We will furnish you with questionnaires and/or worksheets to guide you in gathering the necessary information. Your use of such forms will assist in keeping pertinent information from being overlooked. You represent that the information you are supplying to us is accurate and complete to the best of your knowledge and that you have disclosed all relevant facts.

Our services do not include any procedures designed to discover defalcations or other irregularities, should any exist. However, we will inform you of matters that come to our attention, unless they are clearly inconsequential.

In preparing Form 5500, we will use professional judgment in resolving questions or where there may be conflicts between the authorities' interpretations of the law and other supportable positions. Unless otherwise instructed by you, we will resolve such questions in your favor whenever possible.

You should retain all the documents and other data that form the basis of the Form 5500 filing. These may be necessary to prove the accuracy and completeness of the returns to the Internal Revenue Service and Department of Labor. You have the final responsibility for the return and, therefore, you should review it carefully before you sign it.

Your Form 5500 may be selected for review by the Internal Revenue Service and the Department of Labor. Any proposed corrective adjustments by the examining agent are subject to certain rights of appeal. You have the ultimate discretion in regard to any choices to be made in regard to the named plan.

We have the right to withdraw from this engagement, in our discretion, if you do not provide us with any information we request in a timely manner, refuse to cooperate with our reasonable requests, or misrepresent any facts. Our withdrawal will release us from any obligation to complete your return and will constitute completion of our engagement. You agree to compensate us for our time and out-of-pocket expenses through the date of our withdrawal.

It is our policy to keep records related to this engagement for seven years. However, we do not keep any of your original records, so we will return those to you upon the completion of the engagement. When records are returned to you, it is your responsibility to retain and protect the records for possible future use, including potential examination by the IRS or DOL. By signing this engagement letter, you acknowledge and agree that upon the expiration of the seven year period, we are free to destroy our records related to this engagement.

Our fee for these services will be based upon our standard fee schedule. All invoices are due and payable upon presentation.
