Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FlexSteel Pipeline Technologies, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits – modified cash basis as of November 5, 2024 and December 31, 2023, and the related statement of changes in net assets available for plan benefits – modified cash basis for the period January 1, 2024 to November 5, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of FlexSteel Pipeline Technologies, Inc. 401(k) Profit Sharing Plan and Trust's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 5, 2024 and December 31, 2023 and for the period January 1, 2024 to November 5, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As more fully discussed in Note A, on February 28, 2023, Cactus Wellhead, Inc. acquired FlexSteel Pipeline Technologies, Inc. and the Plan Sponsor, and as a result, the Plan was terminated on February 28, 2023. The Plan was liquidated during the period January 1, 2024 to November 5, 2024.

Basis of Accounting

We draw attention to Note A of the financial statements, which describes the basis of accounting. The financial statements were prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles in the United States. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - FlexSteel Pipeline Technologies, Inc. 401(k) Profit Sharing and Trust (the Plan) was adopted effective July 1, 1998 and restated effective March 1, 2013 to establish a profit-sharing plan and trust for the exclusive benefit of the employees of FlexSteel Pipeline Technologies, Inc. (the Company and Plan Administrator) and Prime Natural Resources, Inc. and their beneficiaries. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On February 28, 2023, Cactus Wellhead, Inc. acquired the Company. The Plan was terminated on February 28, 2023. The participants were given the option to rollover their account to the Cactus Wellhead 401(k) Plan, receive a distribution or rollover their balance to another qualified plan. The Company completed liquidation of the Plan during the period January 1, 2024 to November 5, 2024.

Basis of Presentation - The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States (GAAP). Contributions, interest and dividend income are recognized when received. Benefit payments, corrective distributions and administrative expenses are recorded when paid. Purchases and sales of securities are recorded on a trade date basis. Modification to the cash basis method has been made with respect to the valuation of investments at fair value.

The Plan has opted to apply the practical expedient addressed in FASB ASC 205-30 which allows the financial statements to be presented on a GAAP or modified cash basis instead of the liquidation basis since the impact to the financial statements is not materially different as of November 5, 2024 and December 31, 2023.

Estimates - The preparation of financial statements in conformity with GAAP and in accordance with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits – modified cash basis and the statement of changes in net assets available for plan benefits – modified cash basis.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits – modified cash basis and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits – modified cash basis. (See Note D for discussion of fair value measurements.)

Federal Income Tax - The Company adopted a Volume Submitter Defined Contribution Plan with cash or deferral arrangement (CODA). The Volume Submitter Defined Contribution Plan received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Volume Submitter Defined Contribution Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Volume Submitter Defined Contribution Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan believes all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of November 5, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be recorded when paid and would be classified as tax expense in the statement of changes in net assets available for plan benefits – modified cash basis.

Subsequent Events - The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at November 5, 2024.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee is eligible to become a participant in the Plan after reaching 21 years of age, and to be eligible for profit sharing contributions on the date of hire. Entry dates into the Plan are the first day of each month. Employees covered under a collective bargaining agreement and nonresident aliens are excluded from participation.

Contributions - Participants may elect to make contributions (including Roth contributions) to the Plan in an annual amount ranging from 1% to 96% of their compensation. Contributions are made through authorized payroll deductions. These contributions by individual employees were limited to \$23,000 (participants under 50 years of age) and \$30,500 (participants 50 years of age or older) in 2024. This limitation is adjusted periodically based upon the guidelines under the IRC to reflect cost-of-living increases. There were no contributions during the period January 1, 2024 to November 5, 2024.

Employees are automatically enrolled in the Plan at a 3% deferral rate, increasing 1% annually up to a maximum of 5%, unless the employee elects otherwise.

NOTE B PLAN DESCRIPTION (CONTINUED)

The Company elected to make a safe harbor matching contribution of 100% of employee deferrals up to 3% of employee compensation plus 50% of employee deferrals that exceed 3% but do not exceed 5% of employee compensation. The Company may also make a discretionary profit sharing contribution allocated to participants with one or more years of service employed on the last day of the plan year. There was no discretionary profit sharing contribution for 2024.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Each participant account is credited with the participant's contribution, the Company's contribution, and a pro rata share of the administrative expenses and earnings of each fund in which the participant has invested.

Vesting - A participant is immediately fully vested with respect to all portions of the participant's account.

Forms of Benefits - The normal form of benefit payable under this Plan is a lump sum. A second form of benefit payment is installments over a period of time not to exceed the participant's life expectancy, or the participant's and beneficiary's life expectancies, determined at the time of distribution. Participant accounts less than \$5,000 will be distributed as soon as administratively feasible. Any distribution greater than \$1,000 that is made to a participant without the participant's consent will be rolled over to an individual retirement plan (IRA) designated by the Plan Administrator. Benefits are recorded when paid.

Participants can request distribution of their account balance due to hardship or if terminated prior to the normal retirement age. Participants can also request distribution of their account balance upon attainment of age 59-1/2 years, even if employment is not terminated.

Participant Loans - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and notes receivable from participants. Loan terms range from 1 to 5 years or up to a reasonable period of time exceeding five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. There were no participant loans at November 5, 2024 and December 31, 2023.

Administration - The Company, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. The Plan paid administrative expenses of \$38,220 during 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access. All investments are valued using Level 1 inputs.

Level 2 – Other significant observable inputs (including quoted prices in active and inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments.

NOTE D FAIR VALUE DISCLOSURES (CONTINUED)

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models, discounted cash flow methodologies, or similar techniques, including instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation technique used for investments measured at fair value. There have been no changes in the technique used during 2024 and 2023.

Registered investment companies and interest bearing cash are valued at the market value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation technique is appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers in and/or out of the fair value categories during 2024 and 2023.

NOTE E PARTIES-IN-INTEREST

The Plan invests in various funds offered by Fidelity Management Trust Company. These investments are considered party-in-interest transactions because Fidelity Management Trust Company serves as Plan trustee. The Plan Administrator has approved of these investment options. Fees paid during the year for administrative and other professional services were rendered by parties-in-interest.
