1 – DESCRIPTION OF THE PLAN

General

Hopeful Journeys Educational Center, Inc. 401(k) Profit Sharing Plan (the "Plan") is a defined contribution plan that was established on January 1, 2009 for the benefit of employees of Hopeful Journeys Educational Center, Inc. (the "Organization"). The Plan is funded by contributions from its participants and the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility for Participation

An employee is eligible to enter the Plan on the first day of the quarter following their date of hire. All participants are eligible for discretionary employer matching contributions. To be eligible for discretionary employer non-elective contributions, employees must complete 500 hours of service during the Plan year and are required to be employed on the last day of the Plan year.

Employee Elective Deferral Contributions

Employees participating in the Plan may elect to defer a percentage or flat dollar amount of their annual earnings as their contribution to the Plan, subject to the limitations described in the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

Discretionary Employer Matching and Non-elective Contributions

The Organization may make matching and/or non-elective contributions at its discretion. Non-elective contributions are allocated to participant accounts by employee classification in the ratio that each participant's eligible compensation bears to total eligible compensation paid. The Organization made employer contributions of \$370,786 and \$350,545 for the years ended June 30, 2025 and 2024, respectively.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions is based on a graded vesting schedule whereby the employee is fully vested after 3 years of service.

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions, transfers and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

John Hancock Life Insurance Company (USA) ("John Hancock") served as the Plan's custodian through June 5, 2025, at which time the Plan changed its custodian to Voya Retirement Insurance and Annuity Company ("Voya"). In connection with this change, all participant accounts were transferred from John Hancock to Voya. Upon enrollment into the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of mutual funds offered by Voya (John Hancock through June 5, 2025).

1 – DESCRIPTION OF THE PLAN (continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Effective May 29, 2025 the minimum loan amount increased to \$2,500. Notes receivable from participants are secured by the balances in their accounts and bear interest at a commercially reasonable rate established by the Plan Administrator or under the terms of the applicable funding vehicle. Principal and interest is paid ratably through payroll deductions.

In-service Withdrawals

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan document
- Attainment of age 59 ½

Retirement Benefits

The normal retirement age under the Plan is age 65. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

Upon termination of service from the Organization, participants may elect to receive the vested portion of their accounts in the form of a single lump sum or any other form of settlement available from the manager of the investment fund in which the participants' accounts or portion thereof is invested. Upon termination of service at the Organization, participants with an accumulated balance of \$7,000 (\$5,000 prior to January 1, 2024) or less will receive a distribution of their vested balance at the direction of the Organization.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the custodian.

As of June 30, 2025 and 2024, there were no material distributions payable to participants.

Administrative Expenses

Certain administrative expenses incurred by the Plan are paid by the Organization, and certain administrative expenses are paid by the Plan.

Forfeited Accounts

Forfeitures may be used to pay administrative expenses of the Plan or may be applied to reduce future employer contributions. There was no balance of forfeitures as of June 30, 2025 and 2024.

Participant-Directed Contributions, Withdrawals and Transfers

The manner of electing to allocate contributions between the investment options, and any decision to change such allocation, is made by the participant as permitted by the custodian. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

The Plan presents in the accompanying Statements of Changes in Net Assets Available for Benefits, net investment income, which consists of the realized gains and losses, unrealized appreciation (depreciation) on its investments, and interest and dividend income.

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and, for money market instruments, includes amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Each participant's assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income result in an increase of units of participation while benefits paid and losses result in a decrease of units of participation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of June 30, 2025 and 2024.

Payment of Benefits

Benefits are recorded when processed and approved for payment.

Risks and Uncertainties

The Plan provides for various investment options in various mutual funds and common collective trusts. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan Administrator evaluated events that occurred after June 30, 2025, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, January 27, 2026, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY CUSTODIAN

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's custodians and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the custodians that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual funds and common collective trusts are valued at the daily closing price as reported by the investments. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds and common collective trusts held by the Plan are deemed to be actively traded.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The Fixed Account is reported at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals. Contract value provides a reasonable approximation of fair value.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4 – FAIR VALUE MEASUREMENTS (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with GAAP, investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

6 – PLAN TERMINATION

Although it has not expressed intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, participants will become 100% vested in their aggregate account balances and will be entitled to a lump-sum distribution.

7 – INCOME TAX STATUS

CCH Incorporated (“CCH”) obtained a determination letter from the Internal Revenue Service indicating its CCH Non-Standardized Pre-Approved Profit Sharing Plan with CODA Basic Plan Document #01 (“CCH’s Plan”) is qualified under Internal Revenue Code Section 401. The Company has adopted CCH’s Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to fiscal year 2022.

8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of shares of various accounts and funds managed by John Hancock and Voya. They are the custodians of the Plan’s assets and, therefore, these transactions qualify as party-in-interest.

During the years ended June 30, 2025 and 2024, administrative services were provided to the Plan by John Hancock, Voya and FSM Benefits Plus, Inc., third party administrators.

During the years ended June 30, 2025 and 2024, investment advisory services were provided to the Plan by Affinity Investment Group, LLC (“Affinity”). A member of the Board of Directors of the Organization is the owner of Affinity.

The Organization provides certain administrative services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
