Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan for Employees of Second Harvest Food Bank of Central Florida, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year then ended, June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan for Employees of Second Harvest Food Bank of Central Florida, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

(1) Description of Plan

(a) General

403(b) Thrift Plan for Employees of Second Harvest Food Bank of Central Florida, Inc. (the “Plan”) is a defined contribution plan covering all eligible employees of SHFB (the Company or SHFB). The Plan began operations on July 1, 1998. Employees of the Company are eligible to become participants in the Plan on the first day of the month coinciding with or immediately following their date of hire. Participation in the Plan is voluntary.

(b) Contributions

Under the Plan, eligible participants may elect to contribute a portion of their annual compensation for the year, not to exceed \$23,500 (plus a catch-up contribution limited to \$7,500 for individuals aged 50 or older) in 2025. The Company provides matching contributions to qualified participants. Participants are eligible to receive matching contributions after six months of service. For the year ended June 30, 2025 and 2024, management provided matching contributions equal to 100% of the employee contribution limited to 4% of their compensation in accordance with the terms of the underlying Plan. Employees elect the investment vehicle(s) with the trustee of the Plan in which their funds and employer matching contributions are invested.

(c) Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeitures are non-vested balances in the accounts of participants who terminate employment. Each year the amount of the forfeitures, if any, are used first to pay certain Plan expenses with any remaining amounts used to reduce future employer contributions.

(d) Payments of Benefits

Upon termination of service, a participant may receive the value of the participant’s vested interest in his or her account in a lump-sum amount or in installments.

(e) **Participant Loans**

Participants may borrow from the Plan Administrator up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans to participants are funded by Mutual of America but are secured by the balance in the participant's account plus 20%. The term of the loans does not generally exceed five years. The loans bear interest at a reasonable rate determined by Mutual of America and principal and interest are paid ratably through payroll deductions.

At June 30, 2025 and 2024, participant loans secured by Plan assets as described herein amounted to approximately \$ 155,000.

(f) **Vesting**

Vested rights to Company matching contributions accrue based on years of vesting service, as defined. Vesting accrues at 10% beginning after the participants' first year of service, with full vesting accruing at the end of year five. Forfeitures of Company matching contributions are applied to reduce the employer matching contributions of the following year. Participant contributions are vested immediately.

(g) **Termination**

Upon termination of the Plan or if employer contributions are permanently discontinued, the account of each participant shall fully vest.

(h) **Subsequent Events**

In preparing these financial statements, the Plan has evaluated subsequent events and transactions for potential recognition and disclosure through January 15, 2026, which is the date the financial statements were available to be issued.

(2) **Summary of Significant Policies**

(a) **Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting and present the net assets available for benefits and changes in those assets.

(b) **Valuation of Investments**

Investments are stated at fair market value determined by quoted market prices or their equivalent at the statement of net assets available for benefits date with the exception of certain stable value investment contracts which are stated at contract value, as applicable. Changes in the aggregate market or contract value of the investments are charged or credited to net investment income or loss for the year. Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of investments which amount to approximately \$7,900,000. Investments are monitored monthly by both the trustee and management of the Plan and are not subject to collateralization.

(c) **Payment of Benefits**

Benefits are recorded when paid.

(d) **Tax Status**

The Plan has received a favorable IRS determination letter dated March 31, 2017. The Plan Administrator believes the Plan is operating in accordance with its provisions and is exempt from federal income tax.

(e) **Use of Estimates**

Management of the company has made certain estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities to prepare these financial statements in conformity with generally accepted accounting principles. Actual results could differ from those estimates.

(f) **Fair Value Measurement**

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled separate accounts ("PSA"): The pooled separate accounts are stated at fair value using the net asset value ("NAV") practical expedient as reported to the Plan. The NAV practical expedient is based on the quoted market prices of the underlying mutual funds. The unit value of the pooled separate account is calculated by dividing the total value of the assets of the separate account minus its liabilities by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on NAV, or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares. Those separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable inputs for certain securities. These investments are direct filing entities. There are currently no redemption restrictions or unfunded commitments on these investments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards update No. 2015-07, as the Plan's pooled separate accounts are measured at fair value using the unadjusted NAV, they are not categorized within the fair value hierarchy.

The Plan also invests in a fully benefit-responsive guaranteed investment contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged to participant withdrawals and administrative expenses. Mutual of America, as the guaranteed investment contract issuer, is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for plan benefits at contract value. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(3) Investments

Upon enrollment in the Plan, participants can elect to invest their contributions into the available fund investment vehicle indicated in the accompanying statement of assets available for benefits. Mutual of America is the sole trustee for the participant directed funds for the years ended June 30, 2025 and 2024. Employer contributions are invested into the Participants' accounts based upon the Participants' enrollment investment selection.

(4) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
