Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 financial statements

We have performed an audit of the accompanying financial statements of the Thrive Companies 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report.

Plan management is responsible for the accompanying financial statement of the Thrive Companies 401(k) Profit Sharing Plan, which comprises the statement of net assets available for benefits as of December 31, 2023, and the related notes to the financial statement in accordance with accounting principles generally accepted in the United States of America. We have performed a compilation engagement in accordance with *Statements on Standards for Accounting and Review Services* promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the 2023 financial statement.

Plan Description

The following description of the Thrive Companies 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers all eligible employees of Thrive Companies (the Company) unless the employee is a: union employee; non-resident alien of the United States; and/or a leased employee, as defined by the Plan.

The Plan is a qualified trust under Sections 401(a) and 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan permits eligible employees to make elective deferrals on the first day of the January or the first day of each quarter (April, July and October) following the date they attain age 21 and complete one month of service. The Plan includes an automatic enrollment provision of eligible participants at 6%.

Contributions

Each year, participants may elect to defer up to 100% of their W-2 wages, as defined by the Plan, not to exceed the limits imposed by the Internal Revenue Service (IRS) as either a pre-tax and/or Roth 401(k) deferral. These deferral contributions are fully vested and non-forfeitable. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company may make, at its discretion, a matching contribution to the Plan.

The Plan utilizes the safe-harbor method for employer matching contribution, contributing 100% of the first 4% of each eligible participant's eligible compensation during 2024 and 2023. The Company made matching contributions of \$383,216 and \$366,271 for the years ended December 31, 2024 and 2023, respectively. The plan also provides for a discretionary a discretionary match up to 4% of compensation.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution and allocations of (a) employer contributions, (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in both the Company’s discretionary matching portion of their accounts and the safe harbor matching portion of their accounts, plus actual earnings, is based on continuous years of service according to the following vesting schedule; however, upon reaching normal retirement age, participants become 100% vested in the Company’s matching portion of their accounts, plus actual earnings:

Notes Receivable Participant Loans

Participants may borrow from their fund. The loans are secured by the balance in the participant’s account and bear interest at Wall Street Journal Prime rate plus 1%, which is commensurate with local prevailing rates, and ranged from 8.75% to 9.50% for all notes receivable outstanding at December 31, 2024. Principal and interest are paid ratably through weekly payroll deductions.

Investment Options

A participant may direct Company and participant contributions in any of the various investment options offered by the Plan. Participants may change their investment options at any time. The Plan currently offers several mutual funds as investment options.

Payment of Benefits

A participant may receive the value of his or her vested account upon termination, death, disability or normal retirement. Normal retirement age is 62. Distributions are made in a lump sum payment. In-service withdrawals are permitted for participants who have reached age 59½ or incurred a hardship.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,951 and \$9,439, respectively. Amounts forfeited by participants who terminate service prior to becoming fully vested are used to reduce employer contributions, reduce Plan expenses or reinstate previously forfeited balances of former participants, if any. No forfeitures were used to pay administrative expenses of the Plan during 2024.

SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. However, there is no material impact to the Plan's 2024 and 2023 financial statements.

Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For additional disclosure of investments, see the Fair Value Measurements footnote therein.

Purchases and sales of securities are recorded on the trade date. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan paid administrative expenses of \$36,240 to the trustee of the Plan for the year ended December 31, 2024. All other professional fees for the administration and audit of the Plan are paid by the Company on behalf of the Plan.

Fair Value Measurements

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active or inputs other than quoted prices that are observable for the asset or liability.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan Termination

The Company has the right to discontinue its contributions at any time. Although it has not expressed any intent to do so, the Company also has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participant's accounts will become fully vested.

Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangements (CODA), which obtained its latest prototype opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated the Plan document and related trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Company is relying on the Plan's IRS opinion letter. The Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of December 31, 2024 and 2023, therefore no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions however, there are currently no audits for any tax periods in progress.

Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Professional fees for the administration and audit of the Plan are paid by the Company on behalf of the Plan. Matrix Trust Company provides investment custodial services for the Plan. Therefore, these investments and all transactions with them qualify as party-in-interest transactions in which total fees paid to these parties by the Plan for services rendered amounted to \$36,240 for the year ended December 31, 2024.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, the date the financial statements were available to be issued.
