## 1. Description of Plan

The following description of the Reyco Granning 401(k) Retirement Plan (Plan), sponsored by The Boler Company as of June 1, 2024 and Reyco Granning, LLC for the period January 1, 2023 through May 31, 2024 (Company), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all full-time non-union employees of the Company who have completed more than 1 hour of service and are age eighteen or older and all full-time union employees of the Company who have completed 90 days of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan merger:** The Plan Sponsor was purchased by the Boler Company and as a result, elected to discontinue the Plan effective December 31, 2024. Plan assets and participant balances in the amount of \$6,039,207 were transferred into the Money Accumulation Plan of The Boler Company and Plan assets and participant balances in the amount of \$1,634,140 were transferred into the Tax-deferred Retirement Investment Plan of the Boler Company (existing plans controlled by the acquiring Company).

**Contributions:** Prior to Plan merger, participants could contribute up to 50% of their annual eligible wages by way of salary reductions. Contributions were subject to certain IRS limitations. Participants could elect to classify any portion of their contributions as post-tax (Roth) or pre-tax (Traditional). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

For non-union employees, the Company made matching contributions equal to 100% of the first 3% of the participant's deferral contribution to the Plan and an additional 50% of the next 3% of compensation that a participant contributes to the Plan.

For union employees, the Company made matching contributions equal to 100% of the first 2% of the participant's deferral contribution to the Plan and an additional 50% of the next 2% of compensation that a participant contributes to the Plan.

The Company could also make additional discretionary non-elective (profit sharing) contributions to the Plan to be allocated to each eligible participant as a uniform percentage of eligible compensation. There were no profit-sharing contributions made in 2024 or 2023.

**Participant accounts:** Each participant's account was credited with (a) the participant's contribution, (b) the Company's matching contributions and discretionary non-elective contributions (if any) and (c) plan earnings. Net income and asset revaluation were allocated to each participant based upon the participant's account balance and earnings of the investments selected by the participant. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Prior to December 31, 2024, participants were immediately 100% vested in their voluntary contributions and non-union matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts was based on years of continuous service. A participant was fully vested after five years of credited service.

**Payment of benefits:** Prior to December 31, 2024, a distribution of a participant's vested account balance could be made due to hardship, attainment of age 59 1/2, death, retirement, or upon termination of service with the Company. A distribution of a participant's rollover balance could be made at any time regardless of the limitations described above. Upon termination, distributions of account balances that exceed \$1,000 could elect to receive a lump-sum amount equal to the value of the vested interest in their account. Participants who terminated service and had account balances of \$1,000 or less would receive an automatic distribution of that balance. Benefit payments were recorded when paid.

At December 31, 2024, all participant account balances have been either distributed or transferred.

**Forfeitures:** If any non-vested amounts are forfeited upon termination, the non-vested amounts were used to restore forfeitures, reduce Company contributions made, or to pay reasonable plan expenses. Forfeitures in the amount of \$10,081 and \$7,268 were utilized to reduce Company contributions in 2024 and 2023, respectively. During 2024 and 2023, forfeitures of \$18,473 and \$750, respectively, were used to pay plan expenses. At December 31, 2023, remaining forfeitures in the amount of \$6,467 were available to be used.

**Notes receivable from participants:** Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account, whichever is less. The loans were secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.5%, which is commensurate with prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

## 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements of the Plan are presented in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Cash and cash equivalents:** Cash and cash equivalents include cash, time deposits, certificates of deposit, money market funds, and all highly liquid debt instruments with maturities of three months or less at the date of their acquisition.

**Valuation of investments and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant notes were reclassified as distributions based upon the terms of the plan document.

**Accounting estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Subsequent events:** The Plan's management has evaluated subsequent events between the end of the most recent fiscal year end and October 15, 2025, the date the financial statements were available to be used.

### 3. Risks & Uncertainties

Prior to the merger, the Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 4. Certified Information

Certain information in the accompanying financial statements related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, a qualified institution.

### 5. Plan Merger

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. During 2024, the governing body approved a plan merger. Effective December 31, 2024, all assets of the Plan were distributed or transferred to other plans and the Plan ceased operations.

### 6. Related Party & Party-In-Interest Transactions

The Plan held investments in funds managed by the Plan's asset custodian, John Hancock Life Insurance Company. Investments in these funds \$6,794,046 on December 31, 2023.

During the years ended December 31, 2024 and 2023, fees of \$43,946 and \$22,754 were paid to John Hancock Life Insurance Company, respectively. These fees are included on the related statements of net assets available for benefits with other administrative and investment expenses.

Substantially all the administrative costs of the Plan are paid by the Company. Certain employees serve as the Plan's administrators. The administrators do not receive any compensation for services rendered to the Plan.

### 7. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds in Pooled Separate Accounts (PSAs):* Valued at the net asset value ("NAV") of shares held by the group annuity contract provider using the quoted net asset value of the shares of the underlying mutual funds adjusted for any dividends or distributions received by John Hancock Life Insurance

Company and the daily equivalent of any fee charged pursuant to the contract. The mutual funds held are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 8. Tax Status

The prototype plan, under which the Plan operates, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan was currently designed in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
