Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of the Control Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended April 30, 2025 and 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. (1) Description of Plan

The following description of the Control Technologies, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan established by Control Technologies, Inc. (the "Company") effective May 1, 1988. All employees of the Company are eligible to participate in the Plan immediately upon hire and the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Contributions to the Plan are made by both the Company and the employee. An employee may elect to contribute a percentage or an exact dollar amount of eligible compensation not exceeding the Internal Revenue Code ("IRC") limits.

All newly eligible employees are automatically enrolled into the Plan, unless they elect otherwise, at a 3% deferral rate. This rate will continue to increase by 1% automatically each year until it reaches 10%. Upon enrollment in the Plan, the participant directs contributions in any of the investment fund options offered by the Plan.

The Plan allows for safe harbor employer contributions. Under safe harbor regulations, the Company is required to contribute a minimum of 3% of each participant's eligible compensation to the Plan annually. All participants receive this contribution after they meet the eligibility requirements stated above. Maximum compensation eligible for an allocation is the IRC allowable compensation in effect for the Plan year.

In addition to safe harbor contributions, the Company may make non-elective discretionary contributions to the Plan. In accordance with the Plan, the Company may contribute to the Plan on behalf of six specified groups of participants. Specified groups are based on category of eligible employees and contribution amounts are determined by the Company. The Company must provide the administrator of the Plan with written notification of the amount of contribution to be allocated to each group. Maximum compensation eligible for an allocation is the IRC allowable compensation in effect for the Plan year. In 2025 and 2024, there were no non-elective discretionary contributions.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Earnings are allocated to participant accounts based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested with respect to their deferrals and the employer safe harbor contribution. Non-elective discretionary contributions are subject to the following vesting schedule: Participants are 20% vested after two years of service; the vested portion increases to 40% after three years of service, 60% after four years of service, 80% after five years of service and 100% after six years of service. A participant who dies, retires at or after age 65, or becomes permanently disabled is immediately 100% vested.

(e) Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) participant loans. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the time each loan is disbursed. Principal and interest is paid ratably through weekly payroll deductions.

(f) Hardship Withdrawals

Participants may receive hardship withdrawals for reasons of financial hardship.

(g) Payment of Benefits

Participants or their beneficiaries are entitled to receive a benefit equal to 100% of their account balance upon reaching the normal retirement age of 65, death, or disability. The accrued benefit includes the sum of the value of the participant's employee account, the value of safe harbor contributions, and the vested portion of the value of the related Company non-elective discretionary contributions and forfeitures. These values include the proportionate share of any income, expenses, or gains and losses attributable to the investment of Plan assets.

(h) Administrative Expenses

Certain direct administrative expenses are paid by the Plan. All other administrative expenses are paid by the Company.

(i) Forfeitures

Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are allocated to participants who are eligible for employer contributions and are allocated using the same allocation formulas. Total forfeitures allocated were \$326 and \$0 in 2025 and 2024, respectively. There were \$1,773 and \$821 in unused forfeitures at April 30, 2025 and 2024, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

(b) Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(d) Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(e) Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.

(f) Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

(g) Payment of Benefits

Benefits are recorded when paid.

(h) Subsequent Events

The Plan has evaluated subsequent events through February 5, 2026, the date the Plan's financial statements were available to be issued.

(3) Plan Termination and Amendment

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Additionally, the Company may amend the Plan at any time without the consent of any participant or beneficiary provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefits.

(4) Income Taxes

The Plan is a prototype plan that has obtained a determination letter as of March 31, 2014, stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan administrator and the Plan may rely on the determination letter as to the form of the Plan qualifying under the IRC (except as otherwise noted in the determination letter). Additionally, the Plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and remains tax exempt.

The Plan will recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

(5) Information Certified by the Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments, reflected on the accompanying statements of net assets available for plan benefits as of April 30, 2025 and 2024, the schedule of assets held for investment purposes as of April 30, 2025, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended April 30, 2025 and 2024.

(6) Fair Value Measurements

Generally accepted accounting principles in the United States of America established a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Mutual funds and money market funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
