We have performed an audit of the financial statements of Evans Food Group 401(k) Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 19, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements (2022 and 2023 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2022 and 2023 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 and 2023 Financial Statements section:

- The amounts and disclosures in the accompanying 2022 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2022 and 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2022 and 2023 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Mergers

As discussed in Note 1 to the financial statements, Miller Baking Inc, 401(k) Profit Sharing Plan merged into the Evans Food Group 401(k) Plan & Trust effective April 5, 2022. All plan assets were liquidated and transferred to the Evans Food Group 401(k) Plan & Trust on April 5, 2022. Our opinion has not been modified with respect to this matter.

Also discussed in Note 1 to the financial statements, the Plan Sponsor of Evans Food Group 401(k) Plan & Trust, voted on October 14, 2022, to merge the Plan into the Successwise Pooled Employer 401(k) Plan effective January 19, 2023. All plan assets were transferred to the control of Successwise Pooled Employer 401(k) Plan on January 19, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the 2022 and 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2022 and 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 and 2023 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 and 2023 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2022 Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4(i)—Schedule of Assets (Held at End of Year) as of December 31, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Auditor's Report on the 2021 Financial Statements

We were engaged to audit the 2021 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by a qualified institution. In our report dated April 17, 2023, we indicated that: (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements, and (b) the form and content of the information included in the 2021 financial statements other than that derived from the certified information were presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Evans Food Group 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Evans Food Group and certain affiliates under common ownership (collectively, the Company) who have met the eligibility requirements as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan merger: Effective April 5, 2022, Miller Baking, Inc 401(k) Profit Sharing Plan merged into the Evans Food Group 401(k) Plan & Trust. Total assets transferred into the Plan was approximately \$1,784,004.

On October 14 2022, the Board of Directors agreed to merge the Evans Food Group 401(k) Plan & Trust into a Pooled Employer 401(k) Plan. The effective date of the plan merger is January 19, 2023, when the plan assets were transferred to the Pooled Employer 401(k) Plan. Plan assets transferred to the Pooled Employer 401(k) Plan total \$12,488,089.

Financial statement presentation: These financial statements include the period ended January 19, 2023, and the year ended December 31, 2022. The plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022, as permitted by 29 CFR 2520.104-50, since the following Plan year ended January 19, 2023, is a short year of seven months or less. Accordingly, the Plan has included statements of net assets available for assets as of January 19, 2023, December 31, 2022 and December 31, 2021, along with statements of changes in net assets available for benefits for the period ended January 19, 2023, and year ended December 31, 2022, as required by the Department of Labor (DOL) regulations when such election is made.

Eligibility: Employees over 18 years of age may participate in the Plan at the start of the next calendar quarter after their hire date. There is no service requirement to participate in the Plan. However, an employee is not eligible to participate if he or she is a) a nonresident alien with no U.S. income or all such income is exempt from U.S. income tax or b) considered an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee of ours.

Contributions: Eligible participants may contribute but cannot exceed the lesser of 100% of pre-tax annual compensation or the annual dollar limit on salary deferral contributions, as defined by the Plan. All employees who are eligible to make elective deferrals under this Plan and who have attained age 50 before the close of the plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, the Internal Revenue Code (IRC).

The Plan provides for discretionary Company matching contributions for all eligible participants that are employed each pay period of the Plan year. For the year ended December 31, 2022, the Company matched 100% of the first 3% contributed and 50% of the next 2% contributed.

Note 1. Plan Description (Continued)

Additional discretionary Company contributions may be contributed at the option of the Company. Participants must be employed on the last day of the Plan year and have worked at least 1,000 hours during the year in order to be eligible to receive an allocation of any additional discretionary Company contributions. Allocations are based on each participant's compensation as it bears to total compensation. The Company did not elect to make any additional discretionary Company contributions to the Plan for the period ended January 19, 2023 or the year ended December 31, 2022.

Rollovers: The Plan accepts rollovers from a qualified retirement plan of a prior employer with approval from the Plan Sponsor.

Participant accounts: Each participant's account is credited with the participant's contribution and discretionary Company matching contributions, if any, as well as allocations of: a) any additional discretionary Company contributions, if any, and b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants fully vest in the Company matching contribution and any additional discretionary Company contribution portion of their accounts plus actual earnings thereon upon three years of continuous service, defined as having 1,000 work hours. No partial vesting is allowed prior to that date.

Investment options: Upon enrollment in the Plan, a participant may direct participant contributions and Company matching contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Payment of benefits: Upon termination of service due to death, disability, retirement, attainment of age 59½, or separation from service, a participant will generally receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a rollover to another entity. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time of note origination as determined by the Plan Administrator. Notes must be paid within five years by equal bi-weekly payments. However, notes used to buy a participant's principal residence may be paid over a reasonable period which may exceed five years. Interest rates on participant loans ranged from 5.25% to 9.00% at December 31, 2022, and were 5.25% to 7.50% at December 31, 2021. Principal and interest are paid ratably through payroll deductions.

Forfeited accounts: Forfeitures resulting from non-vested portions of participant accounts may be used to reduce future Company contributions and any Plan administrative expenses. At January 19, 2023, December 31, 2022 and 2021, forfeitures were \$0, \$33,958 and \$19,594, respectively. \$0 and \$451 of forfeitures were used to pay plan expenses during 2023 and 2022, respectively.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported as net assets available for benefits and changes therein. Actual results could differ from those estimates.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Any capital gains or losses are included in net appreciation or depreciation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses are expensed when they are incurred. No allowance for credit losses has been recorded as of January 19, 2023, December 31, 2022 and 2021. Defaulted participant loans are reclassified as distributions if the participant has met the criteria for payment of benefits (Note 1) based upon the terms of the plan document.

Payment of benefits: Benefit payments to participants are recognized when paid.

Excess contributions: Payable for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction in contributions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and requested distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value investments.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through September 18, 2024, the date the financial statements were available to be issued.

The Plan Administrator has obtained a certification from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets and income as of January 19, 2023, December 31, 2022 and 2021, and for the period ended January 19, 2023 and year ended December 31, 2022, is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at January 19, 2023, December 31, 2022 and 2021.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investments companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Shares of common/collective trust fund: Valued at the NAV of shares of the common/collective trust fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets held at fair value as of January 19, 2023.

Investments in the common collective trust fund can be redeemed immediately at the participant level. The Plan is required to provide a 12-to-30-month notice to the fund in order to terminate either their entire amount or a portion of their investment interest at the current NAV per share based on the fair value of underlying assets. The fair value of investments in this category has been estimated using the NAV per share of the investments.

Note 5. Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended January 19, 2023 and year ended December 31, 2022, there were no transfers in or out of Level 3.

Note 6. Related-Party Transactions

Certain plan investments were shares of registered investment companies held by Principal Trust Company (Principal). Principal is the Trustee of the plan assets and, therefore, these transactions qualify as party-in-interest. Principal receives fees from the Plan for their services, which amounted to \$178 and \$89,994 for the period ended January 19, 2023 and year ended December 31, 2022, respectively.

Certain employees of the Company provide trustee and administrative services to the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently operating in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
