We have performed an audit of the accompanying financial statements of Porven, Ltd. 401(k) Retirement Savings Plan, (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the period of August 21, 2024 (plan inception) to December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of the Porven, Ltd. 401(k) Retirement Savings Plan (the “Plan”) is provided for general purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Plan Formation and Transfer of Assets

The Plan was established on August 21, 2024 (the “Inception Date”). On this date, eligible employees of Porven, Ltd. (the “Company”) transitioned from participation in the OpenPEP (the “Multi-Employer Plan”) to the newly formed Plan. In connection with this transition, the portion of assets attributable to the Company’s participating employees under the Multi-Employer Plan were transferred to the Plan on August 21, 2024. The Plan’s initial short plan year is August 21, 2024 through December 31, 2024. Subsequent plan years follow the calendar year.

The transferred assets represented each participant’s fully vested account balance under the Multi-Employer Plan as of the transfer date. These amounts were deposited into the respective participant accounts within the Plan and are presented in the accompanying statement of changes in net assets available for benefits as transfers in for the short plan year ended December 31, 2024. The transfer did not affect participants’ vested balances, rights to benefits, or eligibility under the Plan.

General

The Plan is a defined contribution plan covering substantially all eligible employees (as defined in the plan document) of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The plan administrator oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Eligibility

An eligible employee of the Company becomes an eligible participant in the Plan following two months of service. Participants can enter into the Plan on the first day of the month after satisfaction of the eligibility requirement.

Contributions

Each year, a participant may contribute up to 100% of their eligible compensation to the Plan on a pre-tax basis. Participants are also permitted to make contributions as “Roth” contributions. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants age fifty or older are allowed to make catch-up contributions as defined in the Plan document. The Company may, at its discretion, make matching contributions and profit sharing contributions for the plan year. Participants must earn 1,000 hours of service during the Plan year and be employed at year end to participate in profit sharing contributions.

Contributions (*continued*)

The Plan has an automatic enrollment provision whereby newly eligible employees of the Company are automatically enrolled in the Plan at a pre-tax deferral contribution rate of 4%.

The Company matched an amount equal to 100% of the first 4% of eligible compensation for the period of August 21, 2024 (plan inception) to December 31, 2024. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) Plan earnings and losses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The participant's account is reduced by withdrawals and losses on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

A participant is 100% vested in their contributions plus allocated earnings thereon. Vesting in the Company's matching and profit sharing contributions is based on years of continuous service in accordance with the following schedule:

A participant's vested interest in the Company's matching and profit sharing contributions will be 100% in the event of the following:

- a) Death or disability of a participant while employed by the Company
- b) Attainment by a participant of his/her normal retirement age
- c) Plan termination

Investment Options

Upon enrollment in the Plan, participants may direct their elective contribution and Company contribution into the various investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with market rates as determined by the plan administrator. Loans must be repaid over a period not to exceed 5 years, except in the case of loans incurred for the purchase of a primary residence, which can be repaid over a period of up to 30 years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service for any reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's vested interest is less than \$7,000 and greater than \$1,000, and the participant has not elected a single sum payment, the plan will automatically roll the vested account to an IRA in a direct rollover. If his vested account is \$1,000 or less, and the participant has not elected a single sum payment, the participant's entire vested account shall be paid directly to him. Hardship distributions are allowed under the Plan. Upon reaching age 59½, participants may elect distributions from their accounts without any tax penalty in accordance with the IRC.

Forfeitures

Forfeitures may be first used to pay Plan expenses. Any remaining amounts will be used to reduce future Company contributions payable under the Plan. Unallocated forfeited non-vested accounts totaled \$117,919 at December 31, 2024. During the period of August 21, 2024 (plan inception) to December 31, 2024, no forfeitures were used to reduce Plan expenses or Company contributions.

Revenue Credit Account

The Plan and Fidelity Management Trust Company (the "trustee") have entered into a service-based pricing arrangement whereby a portion of the revenue earned by the trustee is credited to the Plan. Such amounts are accumulated in a Revenue Credit Account, which is an account within the Plan and is similar in design to a forfeiture account. Amounts in the account may be used, at the direction of the Plan sponsor, to pay permitted Plan administrative expenses or to be allocated to participant accounts. The Revenue Credit Account balance totaled \$18 at December 31, 2024. During the year ended December 31, 2024, no administrative expenses were paid from the account and no amounts were allocated to participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024, all of the Plan's investments that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All investments of the Plan are stated at fair value, except for the Lincoln Stable Value Account, which is stated at contract value, as reported by the funds. The registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price, and are deemed to be actively traded. The Common/collective trust fund ("CCT") in which the Plan invests is actively traded and valued using observable market inputs, and the net asset value is based on quoted prices or other market-based valuation inputs for the underlying securities. The Lincoln Stable Value Account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is January 27, 2026.

3. Information Certified *(Unaudited)*

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024, net depreciation in value of investments, interest and dividends, and interest income on notes receivable from participants for the period of August 21, 2024 (plan inception) to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Lincoln Stable Value Account

The Plan offers the Lincoln Stable Value Account (the “Contract”) as an investment option under the Plan. The Contract is a fully benefit-responsive fixed annuity contract issued by The Lincoln National Life Insurance Company and is backed by the general assets of the issuing company. The Contract is designed to provide Plan participants with liquidity, yield and stability. Benefit payments from the Contract are allowed whenever qualifying life events occur (upon retirement, termination and other life events), but voluntary withdrawals for the purpose of transfer to other investments are limited by 90-day equity wash provisions. The crediting rate is determined and declared periodically by a Lincoln executive committee.

The Contract accounts for approximately 2% of the Plan’s investments at December 31, 2024, and represents an obligation from Lincoln as amounts come due. The credit risk of the issuer, Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: A.M. Best (A as of February 2025), Standard and Poor’s (A+ as of July 2024), Moody’s (A2 as of August 2025), and Fitch (A+ as of July 2025).

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. In the case of a partial termination, only those who separate from service will become fully vested.

6. Tax Status

The Company has adopted a volume submitter prototype plan document which received an Internal Revenue Service (“IRS”) opinion letter dated June 30, 2020, which indicated that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examination for any tax periods in progress.

7. Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees of the Plan may borrow from their accounts and such loans qualify as party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Prohibited Transactions

For the period of August 21, 2024 (inception) to December 31, 2024, the Company failed to remit to the Plan certain participants' contributions and loan repayments within the period described by the Department of Labor regulations. Delays in remitting these amounts to the Plan were due to administrative issues. Lost earnings will be calculated and contributed to the Plan by the Company pursuant to the guidance issued by the Department of Labor. This amount will be allocated to the affected participants once the correction process is complete.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported herein the statements of net assets available for benefits.
